**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of July 8, 2016 (“Effective Date”) by and between Sun Perfect Timing Finance, LLC, a Delaware limited liability company (“Grantee”) and The Lang Companies, Inc. (f/k/a Perfect Timing, Inc. and LHI Enterprises, Inc.), a Delaware corporation (“Grantor”). All capitalized terms used herein, but not defined herein, shall have the meanings ascribed to them in the Trademark Security Agreement (as defined below).

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Grantee dated February 22, 2010 (the “Trademark Security Agreement”) that certain First Amendment to Trademark Security Agreement by and between Grantor and Grantee dated September 17, 2012 (the “First Amendment to Trademark Security Agreement”), Grantor granted to Grantee a continuing third priority security interest in all of Grantor’s right, title and interest in the Trademark Collateral, including the United States trademark registrations and United States trademark applications set forth on Schedule I and Schedule I-A attached hereto (such registrations and applications, together with the Trademark Collateral, the “Released Collateral”);

**WHEREAS**, Grantor and Grantee entered into the Trademark Security Agreement and the First Amendment to Trademark Security Agreement pursuant to the terms and conditions of that certain Junior Subordinated Security Agreement by and between Grantor and Grantee dated February 22, 2010;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on February 24, 2010, at Reel 4155, Frame 0320 and the First Amendment to Trademark Security Agreement was recorded with the PTO on September 17, 2012, at Reel 4862, Frame 0753; and


**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Released Collateral.
