TRADEMARK ASSIGNMENT

REFERENCE is hereby made to the DAISY ROCK GUITARS TRANSFER AGREEMENT between the parties dated March 31, 2016 (the "Transfer Agreement"). All undefined capitalized terms herein shall have the meaning ascribed to them in the Transfer Agreement.

WHEREAS, ASSIGNOR owns the U.S. Trademark Registrations and/or Applications set forth in Schedule A, attached hereto and incorporated herein (collectively, the "Marks") together with the goodwill of the business symbolized thereby in connection with the goods/services for which the Marks are used (the "Goods/Services").

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its rights, title, and interest in and to the Marks.

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR's right, title, and interest of whatever kind in and to the Marks, together with: (1) the goodwill of the business relating to the Goods/Services for which the Marks are used and for which they are registered and/or applied, (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including, without limitation, damages and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Marks.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be reasonably necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks.
