RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 15, 2016 ("Effective Date") by **BARCLAYS BANK PLC**, ("Pledgee"), in favor of **NEWPAGE CORPORATION** and **NEWPAGE WISCONSIN SYSTEM INC.** (each, a "Pledgor" and collectively, the "Pledgors"). Capitalized terms used but not defined in the Release have the meaning ascribed thereto in the Collateral Agreements (defined below).

WHEREAS, the Pledgors and Pledgee entered into that certain Trademark Security Agreement dated January 28, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement (DIP ABL Facility) dated as of January 28, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement", and together with the Trademark Security Agreement, the "Collateral Agreements"), among NewPage Investment Company, NewPage Corporation (the "Borrower"), each a subsidiary of the Borrower identified therein and Pledgee, as Collateral Agent.

WHEREAS, pursuant to the terms and conditions of the Collateral Agreements, each Pledgor assigned and pledged to Pledgee, in its capacity as Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties (as defined in the Collateral Agreement), a security interest (the "Security Interest") in all of each Pledgor's right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement), including any and all of the following assets, then owned or at any time thereafter acquired by any such Pledgor or in which any such Pledgor then had or at any time thereafter may have acquired any right, title or interest (collectively, but excluding any Excluded Property, the "Trademarks"): (i) all trademarks, service marks, corporate names, company names, business names, trade dress, logos and taglines, all registrations thereof (if any), and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States of America, and all renewals thereof, including those listed on Schedule I and; (ii) all goodwill associated therewith or symbolized thereby; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 29, 2016, at Reel No. 5719, Frame No. 0389.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Pledgee, without representation, warranty or recourse of any kind (i) hereby terminates the Trademark Security Agreement, and hereby terminates, discharges, cancels and releases in full any and all security interests (including the Security Interest) it has in, to and under the Trademarks and (ii) re-assigns to each applicable Pledgor any and all such right, title and interest that it may have in the applicable Trademarks to such Pledgor.

Pledgee shall take all further actions, and provide to each Pledgor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without


limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Pledgor, and at such Pledgor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release. Pledgee authorizes and requests that the United States Patent and Trademark Office and any applicable government officer note and record the release hereby given and any other filings necessary to evidence the release and termination of the Pledgee's rights under each of the Collateral Agreements, with respect to the Trademarks.

This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
