TRANSFER OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

WHEREAS, the Security Agreement required the Grantors to execute and deliver to Predecessor Agent, and Predecessor Agent caused to be recorded with the United States Patent and Trademark Office: (i) that certain Grant of a Security Interest – Patents, dated as of February 6, 2015, by OTG Experience, LLC ("OTG Experience") and Flo Solutions, LLC ("Flo") in favor of Predecessor Agent, recorded at Reel/Frame No. 034946/0026, (ii) that certain Grant of a Security Interest – Patents, dated as of August 7, 2015, by OTG Experience and Flo in favor of Predecessor Agent, recorded and Reel/Frame No. 036332/0157, (iii) that certain Grant of a Security Interest – Trademarks, dated as of August 7, 2015, by OTG Experience in favor of Predecessor Agent, recorded at Reel/Frame No. 5597/0946 and (iv) that certain Grant of a Security Interest – Trademarks, dated as of December 11, 2012, by OTG Experience in favor of Predecessor Agent, recorded at Reel/Frame No. 4963/0008 (the foregoing (i) through (iv), the "Intellectual Property Security Agreements");

WHEREAS, pursuant to each Intellectual Property Security Agreement, the Grantors granted Predecessor Agent a continuing security interest in the Collateral defined therein (collectively, the “Intellectual Property Collateral”); and



NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Predecessor Agent hereby unconditionally and expressly conveys, assigns and transfers to Successor Agent (without any representation or warranty, and without recourse to Predecessor Agent or any current or former Lender) its liens on and security interests in the Intellectual Property Collateral, including, without limitation, the Trademarks listed on Schedule A attached hereto and made part hereof and the Patents listed on Schedule B attached hereto and made part hereof, which liens and security interests were established under and pursuant to the Intellectual Property Security Agreements.
