RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of July 28, 2016, by KOREA DEVELOPMENT BANK, as security agent (the "Security Agent"), for each of the Secured Parties in favor of FILA LUXEMBOURG S.A.R.L., a Luxembourg private limited liability company (société à responsabilité limitée), having its registered office at 26, Boulevard Royal, L-2449 Luxembourg, Grand Duchy of Luxembourg, registered with the Luxembourg Register of Commerce and Companies under number B 94.195 and with a share capital of EUR 2,482,425 (the "Grantor").

WHEREAS, the Grantor entered into a Security Agreement, dated as of October 31, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), with the Security Agent whereby the Grantor granted to the Security Agent, for the benefit of the Secured Parties, a security interest in and to the Trademark Collateral (as defined below) of the Grantor, among other Collateral;

WHEREAS, under the terms of the Security Agreement, the Grantor executed that the Trademark Security Agreement, dated as of October 31, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on November 10, 2011 at Reel 004659 and Frame 0175, with respect to U.S. trademarks and trademark applications; and

WHEREAS, in accordance with the provisions of the Security Agreement and the Trademark Security Agreement, the Security Agent now desires to release, terminate and extinguish in full all of its security interest and liens in and to the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Security Agent acting on behalf of the Secured Parties under the Security Agreement hereby releases all of its rights in and to the Trademark Collateral and reconveys to the Grantor any and all of the Security Agent's right, title, and interest in, to and under the following (the "Trademark Collateral"), all without warranty or representation of any kind:

a. the trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos and other source or business identifiers, referred to in Item A of Schedule I hereto and all goodwill of the business associated therewith, whether currently in use or not, all registrations and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent

and Trademark Office or in any office or agency of the United States of America or any State thereof, and all common law rights relating to the foregoing, and (y) the right to obtain all reissues, extensions or renewals of the foregoing (collectively referred to as the "<u>U.S. Trademarks</u>");

- b. all of the goodwill of the business connected with the use of, and symbolized by the items described in, clause (a);
- c. the right to sue third parties for past, present and future infringements of any Collateral described in clause (a); and
- d. all Proceeds of, and rights associated with, the foregoing, including any claim by the Grantor against third parties for past, present or future infringement or dilution of any U.S. Trademark, U.S. Trademark registration or U.S. Trademark license, or for any injury to the goodwill associated with the use of any such U.S. Trademark or for breach or enforcement of any U.S. Trademark license and all rights corresponding thereto throughout the world.

All other security interest granted to the Security Agent under the Security Agreement remain in full force and effect and are not being released by this Release.

SECTION 2. <u>Recordation</u>. The Security Agent hereby authorizes and requests that the Director of the United States Patent & Trademark Office and the Commissioner for Trademarks, as applicable, record this Release.

SECTION 3. <u>Definitions</u>. Capitalized terms used herein but not otherwise defined herein shall have the meanings assigned to such terms or incorporated into the Security Agreement.

SECTION 4. <u>Governing Law</u>. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
