### RELEASE OF INTELLECTUAL PROPERTY COLLATERAL AGREEMENT

This RELEASE dated as of August 1, 2016, is made by HSBC Bank USA, National Association, as Collateral Agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of Samsonite IP Holdings S.à r.l., a société à responsabilité limitée (private limited liability company) governed by the laws of the Grand-Duchy of Luxembourg, having its registered office at 13-15 avenue de la Liberté, L-1931 Luxembourg, registered with the Luxembourg Register of Commerce and Companies (Registre de Commerce et des Sociétés, Luxembourg) under number B 147.735 with a share capital of USD 114,115,900 (the "Grantor"). All capitalized terms used herein that are not otherwise defined herein shall have the respective meanings ascribed thereto in the Credit Agreement and the IP Collateral Agreement, as applicable, as described below.

Reference is made to: (a) the Second Amended and Restated Credit Agreement, dated as of June 17, 2014 (the "Credit Agreement"), among Samsonite International S.A., a société anonyme (public limited liability company) governed by the laws of the Grand-Duchy of Luxembourg, having its registered office at 13-15 avenue de la Liberté, L-1931 Luxembourg, registered with the Luxembourg Register of Commerce and Companies (Registre de Commerce et des Sociétés, Luxembourg) under number B 159469 (sometimes hereinafter referred to as the "Company"), Samsonite LLC, a Delaware limited liability company ("Samsonite LLC"), Samsonite Europe NV, a limited liability company (naamloze vennootschap) having its registered office at Westerring 17, 9700 Oudenaarde, Belgium and registered with the Crossroad Bank of Enterprises under number 0550.947.033 RPR Ghent, Oudenaarde ("Samsonite Europe"), Samsonite Company Stores, LLC, an Indiana limited liability company ("Samsonite Stores" and, together with the Company, Grantor, Samsonite LLC and Samsonite Europe, each a "Borrower" and collectively, the "Borrowers"), and HSBC Bank USA, National Association, as administrative agent and collateral agent and (b) the Intellectual Property Collateral Agreement (the "IP Collateral Agreement") and the Short-Form Intellectual Property Collateral Agreement, each dated as of June 16, 2011 (collectively the "Collateral Agreement"), between the Grantor and the Collateral Agent.

Pursuant to the Collateral Agreement, the Grantor granted a security interest to the Collateral Agent, for its benefit and the benefit of the Secured Parties, in certain Collateral (as defined in Section 2.1 to the IP Collateral Agreement) of the Grantor, including but not limited to that set forth on Schedule I hereto (the "Collateral"), which security interest was recorded with the United States Patent & Trademark Office and the EUIPO (formerly the Office for Harmonization in the Internal Market) with respect to the Trademarks set forth on Schedule I hereto.

In connection with the termination of the Credit Agreement, the Grantor has informed the Collateral Agent of its desire to obtain the release of all rights, title and interest of the Collateral Agent in and to the Collateral granted under the Collateral Agreement.

Accordingly, for good and valuable consideration, receipt of which is acknowledged, the Collateral Agent hereby releases all rights, title and interest (including, without limitation, security interests) in and to the Collateral, except to the extent that any expense reimbursement,

indemnification or other provision of any of the Collateral Agreement expressly survives termination of the Collateral Agreement.

Upon the reasonable request of the Grantor, the Collateral Agent will provide, at the Grantor's expense, the Grantor with any information and additional authorization reasonably necessary to effect the release of the Collateral Agent's security interest in the Collateral.
