RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "**Release**") is made as of August 3, 2016, among, inter alios, ICON HEALTH & FITNESS, INC., a Delaware corporation (the "**Company**"), ICON INTERNATIONAL HOLDINGS, INC., a Delaware corporation ("**International**"), UNIVERSAL TECHNICAL SERVICES, a Utah corporation ("**Universal**"), FREE MOTION FITNESS, INC., a Utah corporation ("**Free Motion**"), ICON IP, INC., a Delaware corporation ("**ICON IP**"), ICON DU CANADA INC., a corporation organized under the laws of Quebec ("**ICON du Canada**") and each Additional Grantor (as defined in the Agreements, such Additional Grantors, together with the Company, International, Universal, Free Motion, ICON IP and ICON du Canada, collectively, the "**Grantors**") and WILMINGTON TRUST, NATIONAL ASSOCIATION (as successor by merger to Wilmington Trust FSB), as collateral agent for itself and the Secured Parties (in such capacity, the "**Collateral Agent**").

WHEREAS, in connection with certain loan documents, Grantors and Collateral Agent entered into certain security agreements for the purpose of securing certain obligations of Grantors to Collateral Agent (on behalf of certain lenders and secured parties), including that certain (i) Security Agreement, dated October 8, 2010, among the Grantors and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), (ii) Patent Security Agreement, dated October 8, 2010 and recorded with the United States Patent and Trademark Office (the "**USPTO**") on November 3, 2010 at Reel/Frame 025309/0683, among the Grantors and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Patent Security Agreement**"), (iii) Trademark Security Agreement, dated October 8, 2010 and recorded with the USPTO on November 4, 2010 at Reel/Frame 004309/0270, among the Grantors and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Trademark Security Agreement**"), and (iv) Copyright Security Agreement, dated October 8, 2010 and recorded with the United States Copyright Office on November 4, 2010 at Microfilm No. V3591D026, among the Grantors and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Copyright Security Agreement**"), together with the Security Agreement, the Patent Security Agreement and the Trademark Security Agreement, the "**Agreements**");

WHEREAS, pursuant to the Agreements, Grantors granted the Collateral Agent, for the benefit of itself and the Secured Parties, a security interest in all of the Patent Collateral, Pledged Trademarks, Registered Copyrights, Unregistered Copyrights, Copyright Rights and Copyright Proceeds (as such terms are defined in the Agreements) (collectively hereinafter the "**Intellectual Property**"), including the Intellectual Property identified on Exhibits A, B, and C, attached hereto, and pledged and mortgaged (but did not transfer title to) the Intellectual Property to the Collateral Agent; and

WHEREAS, the Company has requested that the Collateral Agent release its security interest in and to the Intellectual Property, including the Intellectual Property identified on Exhibits A, B and C attached hereto.

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Agreements:

1. Definitions. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Agreements, as applicable.
2. Release. The Collateral Agent, without representation, warranty or recourse of any kind express or otherwise, at the sole cost and expense of the Grantors, hereby releases, discharges, terminates and cancels its security interest under the Agreements, including its security interest in the Intellectual Property, including without limitation, the Intellectual Property identified on Exhibits A, B, and C attached hereto, and the Collateral Agent hereby assigns, conveys and transfers to Grantors, without any representation, warranty, or recourse whatsoever, the Collateral Agent's entire right, title, and interest in and to the Intellectual Property, effective as of the date set forth above.
3. Termination. The Collateral Agent, on behalf of itself and the Secured Parties, without representation, warranty or recourse of any kind, express or otherwise, terminates and cancels each of the Agreements, other than those obligations that expressly survive the termination of each of the Agreements.
4. Further Assurances. The Collateral Agent agrees to take (and hereby authorizes each Grantor (and their respective designees) to take) all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments provided to it), reasonably requested by the Grantors, at the Grantors' sole cost and expense, necessary to more fully and effectively effectuate the purposes of this Release.
5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
6. Counterparts. This Release may be executed in two or more counterparts, each of which shall constitute an original but all of which, when taken together, shall constitute but one contract. Delivery of an executed counterpart to this Release by facsimile transmission or other electronic transmission (including by "pdf" or "tif") shall be as effective as delivery of a manually signed original
