If and to the extent Lender has acquired any right, title or interest in or to any of the Trademark Collateral pursuant to the terms of the Trademark Agreements, Lender hereby reassigns and transfers such right, title and interest to Company, without any representation, warranty or undertaking by, or recourse to, Lender.
