**TRADEMARK SECURITY AGREEMENT**

This TRADEMARK SECURITY AGREEMENT (this "Agreement") is dated as of July 28, 2016, between THE OUTDOOR RECREATION GROUP, a California corporation ("TORG"), THE OUTDOOR RECREATION GROUP, LLC, a California limited liability company (together with TORG, the "Grantors"), and PNC BANK, NATIONAL ASSOCIATION ("PNC"), as administrative agent for Lenders described below (PNC, in such capacity, "Agent").

**W I T N E S S E T H:**

WHEREAS, pursuant to that certain Revolving Credit and Security Agreement dated as of the date hereof by and among Grantors, the other Persons named therein as Borrowers, Agent and the Persons signatory thereto from time to time as the Lenders (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement"), the Lenders have agreed to make loans to or for the benefit of Grantors and the other Borrowers; and

WHEREAS, as security for the Borrowers' obligations under the Credit Agreement, pursuant to the terms of the Credit Agreement, Grantors granted to Agent, for the benefit of Agent and the Lenders, a Lien on all trademarks of Grantors, whether now owned or existing or hereafter acquired or arising, provided, that any such trademark shall exclude Excluded Property.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantors hereby agree as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Grantors hereby grant to Agent, on behalf of itself and the Lenders, a Lien upon all of Grantors' presently existing or hereafter arising right, title and interest in and to all registered trademarks referred to on Schedule A hereto (the "Registered Trademarks"), provided, however, that the Registered Trademarks shall exclude Excluded Property.

3. AGREEMENT. The security interests granted pursuant hereto are one and the same as those granted to Agent, on behalf of itself and the Lenders, pursuant to the Credit Agreement. Grantors hereby acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Registered Trademarks made and granted hereby are more fully set forth in the Credit Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. COUNTERPARTS. This Agreement may be executed via telecopier or facsimile transmission or electronic transmission (i.e., e-mail) in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all of which counterparts together shall constitute one and the same instrument.

5. APPLICABLE LAW. THIS AGREEMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE INTERNAL LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES.


