WHEREAS, on March 13, 2015, the Assignor filed a voluntary petition for reorganization pursuant to Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court, District of New Jersey, Newark Division (the “Bankruptcy Court”), and captioned In re Marburn Stores, Inc., Case No. 15-14411-VFP; and

WHEREAS, pursuant to that certain Asset Purchase Agreement between the Grantor and G-MAXX Group, LLC (the “Assignee”), dated, as of August 1, 2016, and amended by an Amendment to Asset Purchase Agreement, dated as of August 19, 2016, and subject to the sale order of the Bankruptcy Court approving such sale, the Grantee is acquiring substantially all of the assets of the Grantor, including but not limited to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the Grantor, for itself and its successors and assigns does hereby collaterally transfer, assign and set over unto Grantee, its successors, transferees and assigns, all of its present and future right, title and interest in and to the Trademarks, the goodwill of the business associated with such Trademarks and all proceeds thereof and all rights and proceeds associated therewith.

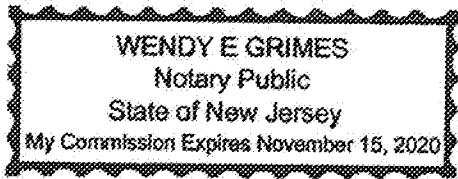
