RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF LIEN (this "*Release*") is made as of June 22, 2016 (the "*Effective Date*") by Morgan Stanley Senior Funding, Inc., as collateral agent (the "*Agent*") in favor of Freescale Semiconductor, Inc. (the "*Issuer*"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the 5% Notes Security Agreement (as defined below).

WHEREAS, the Issuer entered into that certain amended and restated indenture (the "Amended 5% Indenture"), dated as of December 7, 2015 (as amended, amended and restated, supplemented or other modified from time to time prior to the date hereof) which amended and restated the Indenture dated as of May 21, 2013, pursuant to which the Issuer issued \$500,000,000 aggregate principal amount of 5.000% senior secured notes due 2021 (the "5% Notes") to the holders thereof;

WHEREAS, In connection with its obligations under the 5% Notes (the "Obligations"), the Issuer is party to that that certain Security Agreement, dated as of May 21, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, including pursuant to the Amendment to Security Agreement dated as of December 7, 2015), between the Agent, the Issuer and each of the other Grantors from time to time party thereto (as defined therein) (as so amended, the "5% Notes Security Agreement");

WHEREAS, In connection with the Amended 5% Indenture and the 5% Notes Security Agreement, the Issuer entered into that certain Assignment and Assumption, dated as of December 7, 2015, which assigned to the Agent, for its benefit, a continuing first priority security interest in and to all of its right, title and interest in, to and under all of its trademarks listed on Schedule A hereto (the "Trademarks") as security for the due and punctual payment and performance in full, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, of the Obligations; and

WHEREAS, Agent acknowledges full performance of the Obligations and accordingly requests a specific release of the security interest granted and recorded against all of the Trademarks of the Issuer pursuant to the 5% Notes Security Agreement (including, but not limited to, those items set forth on Schedule A hereto and/or identified in the Security Agreements).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, on behalf of itself and its respective successors and assigns, hereby: (i) fully releases and discharges any and all liens, security interests, right, title and interest it may have, in whole or in part, in, to and under all of the Trademarks of the Issuer granted to the Agent pursuant to the 5% Notes Security Agreement, together with the goodwill of the business symbolized thereby and all applications and registrations related thereto; (ii) re-assigns to the Issuer any and all such right, title and interest that it may have in any such Trademarks; (iii) agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights to the Issuer; and (iv) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Agent's rights under each of the Amended 5% Indenture and the 5% Notes Security Agreement, with respect to any such Trademarks.

Notwithstanding anything herein (or in any other document, communication or filing relating hereto by any person) to the contrary, the Agent is authorizing solely the release of the security interests granted pursuant to the 5% Notes Security Agreement and the Issuer's obligations under the 5% Notes, and not any other liens or security interests at any time granted by the Issuer or any other Grantor in favor of Morgan Stanley Senior Funding, Inc. or in favor of any other person.
