UNDER SECTION 905 OF THE BUSINESS CORPORATION LAW

Pursuant to Section 905 of the Business Corporation Law of the State of New York (the "BCL"), the undersigned corporation hereby executes and delivers to the Department of State of the State of New York (the "DOS") the following Certificate of Merger:

FIRST: The name and state of incorporation of each constituent corporation is as follows:

(a) General Electric Company, a New York corporation (the "Surviving Corporation"), was incorporated by special act of the New York Legislature, Chapter 323, Laws of 1892, effective April 15, 1892; and

(b) General Electric Capital Corporation, a Delaware corporation (the "Subsidiary Corporation"), filed its certificate of incorporation on December 2, 2015.

(c) As of the date hereof, the Subsidiary Corporation has not filed an application for authority to do business in the state of New York.

SECOND: The Surviving Corporation owns 451,000 shares of common stock, par value \$14.00 per share, of the Subsidiary Corporation (the "Common Shares"). The Common Shares constitute the only issued and outstanding class of stock of the Subsidiary Corporation. The Surviving Corporation owns 100% of the issued and outstanding Common Shares.

THIRD: The Subsidiary Corporation shall be merged with and into the Surviving Corporation in accordance with Section 905 of the BCL and the Surviving Corporation shall be the surviving corporation of the merger.

FOURTH: A plan of merger has been adopted by the board of directors of the Surviving Corporation.

FIFTH: The merger herein certified is permitted by the laws of the jurisdictions of incorporation of the Surviving Corporation and Subsidiary Corporation and is in compliance with said laws.

SIXTH: The merger herein certified shall be effective upon filing of this certificate of merger by the DOS.
