CERTIFICATE OF OWNERSHIP AND MERGER

MERGING

KYOCERA COMMUNICATIONS, INC., A DELAWARE CORPORATION

WITH AND INTO

KYOCERA INTERNATIONAL, INC., A CALIFORNIA CORPORATION

(Pursuant to Section 253 of the General Corporation Law of Delaware)

Kyocera International, Inc., a corporation organized and existing under the laws of the State of California (the "Corporation"), does hereby certify:

1. That the Corporation was incorporated on July 2, 1969, pursuant to the provisions of the California Corporations Code, the provisions of which permit the merger of a corporation of another jurisdiction with and into a corporation organized and existing under the laws of the State of California.

2. That the Corporation owns 100% of the capital stock of Kyocera Communications, Inc., a corporation incorporated on February 15, 2008, pursuant to the provisions of the General Corporation Law of the State of Delaware.

3. That on June 29, 2016, the board of directors of the Corporation adopted the following resolutions by unanimous written consent to merge Kyocera Communications, Inc. with and into the Corporation, with the Corporation being the surviving entity:

WHEREAS, it is deemed advisable and in the best interest of the Corporation that the Corporation merge its wholly-owned subsidiary, Kyocera Communications, Inc., a Delaware corporation, with and into the Corporation as the surviving corporation (the "Merger");

WHEREAS, pursuant to the Merger, the existing shares of Kyocera Communications, Inc. shall cease to exist and the Corporation shall succeed by virtue of the Merger to all properties, franchises, powers, rights, and immunities of Kyocera Communications, Inc., and the Corporation shall be subject to all the debts and liabilities of Kyocera Communications, Inc.;

WHEREAS, a proposed Certificate of Ownership to be filed with the Secretary of State of the State of California (the "California Certificate") has been presented to and considered by the directors; and

WHEREAS, a proposed Certificate of Ownership and Merger to be filed with the Secretary of State of the State of Delaware (the "Delaware Certificate") has been presented to and considered by the directors.

NOW, THEREFORE, BE IT RESOLVED, that the Corporation merge Kyocera Communications, Inc., its wholly-owned subsidiary corporation, into itself and assume all its obligations pursuant to Section 1110 of the California Corporations Code;

RESOLVED FURTHER, that the Merger shall become effective on June 30, 2016 at 11:59 p.m. Eastern Time; and

RESOLVED FURTHER, that any officer of the Corporation, acting alone, is hereby authorized and directed to prepare, execute and deliver and any and all agreements, deeds, assignments, and other instruments or documents that he or she may deem necessary or desirable to effectuate the purposes of these resolutions, including, but not limited to, the California Certificate, the Delaware Certificate, final tax returns, and assignment and assumption agreements, all of which may be in such form and contain such terms and provisions as said officer may deem proper.


4. The Corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of Kyocera Communications, Inc., as well as for enforcement of any obligation of the Corporation arising from this merger, including any suit or other proceeding to enforce the right of any stockholders as determined in appraisal proceedings pursuant to Section 262 of the General Corporation Law of Delaware, and irrevocably appoints the Secretary of State of Delaware as its agent to accept services of process in any such suit or proceeding. The Secretary of State of the State of Delaware shall mail any such process to the Corporation at 8611 Balboa Avenue, San Diego, California 92123.

5. The effective time of this Certificate of Ownership and Merger shall be June 30, 2016 at 11:59 p.m. Eastern Time.
