TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS, dated as of September 19, 2016 (this "Termination and Release"), by Credit Suisse AG, as Collateral Agent (as defined below), in favor of AMF Bowling Worldwide, Inc., Strike Holdings LLC and Leiserv, LLC (each, a "Grantor" and collectively, the "Grantors"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable, referred to below.

Reference is made to (i) the Credit Agreement dated as of September 18, 2014 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Credit Agreement"), among Bowlmor AMF Corp. ("Holdings"), AMF Bowling Centers, Inc. (the "Borrower"), the lenders from time to time party thereto (the "Lenders") and Credit Suisse, AG, as Issuing Lender and Administrative Agent (in such capacity, the "Administrative Agent"), (ii) the Guarantee and Collateral Agreement dated as of September 18, 2014 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Guarantee and Collateral Agreement"), among Holdings, the Borrower, the Subsidiary Guarantors from time to time party thereto and Credit Suisse AG, as Control Agent and Collateral Agent (the "Collateral Agent") and (iii) the Trademark Security Agreement dated as of September 18, 2014 (the "Trademark Security Agreement"), among the Grantors and the Collateral Agent (the documents set forth in clauses (i) through (iii) collectively, the "Security Agreements").

WHEREAS, pursuant to the Security Agreements, the Grantors granted to the Collateral Agent, for the benefit of the Finance Parties, a security interest in all right, title or interest of the Grantors in certain intellectual property, including the trademarks and trademark applications of the Grantors set forth on Schedule I hereto (collectively, the "*Trademarks*"), which security interests were recorded with the United States Patent & Trademark Office on November 10, 2014 at Reel/ Frame 5398/565.

WHEREAS, pursuant to the Payoff Letter dated as of September 19, 2016, the Collateral Agent agreed to release all right, title and interest granted to it, for the benefit of the Finance Parties, under the Security Agreements in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has in and against the Trademarks and (iii) reassigns all right, title and interest it may have in, to or under the Trademarks, together with the goodwill associated therewith, including without limitation any renewals of any of the foregoing, and any proceeds of the foregoing, and any claims against third parties for past, present or future infringement or dilution of the Trademarks, to the applicable Grantor.
