WHEREAS YTL (directly and through its predecessors in title) has provided to its customers multiple user access to a global computer network under the trademark "YANDEX" since as early as September 23, 1997; and

WHEREAS YTL obtained a trademark registration with the United States Patent and Trademark Office for "YANDEX" in International Class 9 under registration number 2760594; and

WHEREAS YTL filed a trademark application with the United States Patent and Trademark Office for "YANDEX" in International Classes 38 and 42 under serial number 76567968; and

WHEREAS YTL seeks to transfer its trademark rights to YL;

NOW THEREFORE YTL and YL hereby agree as follows:

1.0 For consideration \$3000.00 (Three thousand US dollars) the sufficiency of which is hereby acknowledged, YTL hereby assigns to YL and YL accepts all right, title and interest to the mark "YANDEX" in the United States of America and to US PTO registration number 2760590 and serial number 76567968, together with the goodwill of the business in which the mark is used and symbolized by the mark. YTL agrees to execute and deliver at the request of YL all papers, instruments and other things and to perform such other reasonable acts as may be required by YL in order to give effect to this Agreement.

Consideration hereof includes VAT of RF 18%. Payment should be made to the bank account of YTL under the invoice issued by YTL, before March, 31st, 2006.


2.0 This Agreement and any matter relating thereto shall be governed and construed in accordance with the laws of the State of Massachusetts.

- 5.0 No modification or amendment to the terms of this Agreement shall be effective unless in writing and signed by the duly authorized representatives of YTL and YL.
- 11.0 Any notices, requests, or demands shall be in writing and delivered by facsimile or prepaid courier to the other at the address as specified herein subject to change by either party upon giving the other notice in writing, as herein provided, of such change.



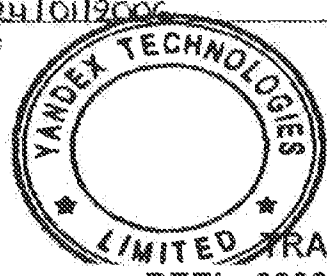
