RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest ("<u>Release</u>") is executed and delivered on this 4th day of October 2016, by JPMORGAN CHASE BANK, N.A. (the "<u>Bank</u>"), to THE MALNATI ORGANIZATION, LLC (successor to The Malnati Organization, Inc., the "<u>Grantor</u>"), as follows:

WHEREAS, pursuant to that certain Credit Agreement dated as of December 21, 2012 by and among the Grantor, the other parties named as "Loan Parties" therein, and the Bank (as restated as of December 29, 2014 and as otherwise amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Grantor and the Bank entered into that certain Trademark Security Agreement dated as of December 21, 2012 (the "Security Agreement");

- 3. all products and proceeds of the foregoing, including without limitation, any claim by the Grantor against third parties for past, present or future infringement of any trademark, including without limitation, any trademark referred to in Schedule 1 annexed hereto, any trademark issued pursuant to a trademark application referred to in Schedule 1 and any trademark licensed under any trademark license listed on Schedule 1 annexed hereto (items 1 through 3 being herein collectively referred to as the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded in the United States Patent & Trademark Office ("USPTO") on December 21, 2012, at reel/frame 4926/0926; and

WHEREAS, the Grantor has satisfied the terms of Credit Agreement (including all conditions for release), and the Bank wishes to release its security interest in all of the Grantor's right, title and interest in, to and under the Trademark Collateral, including those items of Trademark Collateral listed on <u>Schedule 1</u> and retransfer and reassign to the Grantor without recourse all of the Bank's right, title and interest in and to the Trademark Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby (i) unconditionally terminates the Security Agreement and terminates, releases and discharges any

and all security interest, right, title or other interest it may have in the Trademark Collateral, including those items listed on <u>Schedule 1</u>, and hereby reassigns any and all right, title and interest it may have in and to the Trademark Collateral without recourse to the Grantor, together with the goodwill of the business symbolized thereby and (ii) agrees to execute, acknowledge, procure and deliver to Grantor any and all further documents or instruments and do any and all further acts which the Grantor (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and Grantor's (or their assignees') right, title and interest in and to the Trademark Collateral. The Grantor, or its designee, may record this Release in the USPTO and in any other offices as may be necessary to carry out the intention of this Release and, to the extent applicable, the Bank authorizes and requests that the USPTO record this Release.
