**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of the 28<sup>th</sup> day of October, 2016, by BMO Harris Bank N.A., a national banking association (“Lender”), in favor of Life Spine, Inc., a Delaware corporation (“Borrower”).

**WITNESSETH:**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases and terminates its security interests in all trademarks, trademark applications and trademark licenses, including without limitation those more particularly described in Schedule A attached hereto and made a part hereof (collectively, the “Released Trademarks”), and reassigns to Borrower all right, title and interest of Lender in and to the Released Trademarks.
