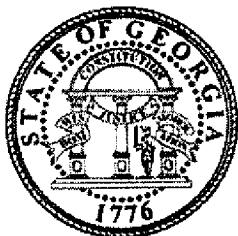


FIRST: That the name of the corporation is Rock-Tenn Shared Services, LLC.
