RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of November 9, 2016, is executed by PROJECT IVORY ACQUISITION, LLC (as successor-in-interest to WLR RECOVERY FUND IV, L.P. and to CLEARLAKE CAPITAL PARTNERS, LLC), in its capacity as Collateral Agent under that certain Senior Subordinated Note Purchase Agreement (in such capacity, together with its predecessors-in-interest, “Agent”), dated as of June 6, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the “Note Purchase Agreement”), in favor of INTERNATIONAL TEXTILE GROUP, INC., APPAREL FABRICS PROPERTIES, INC., BURLINGTON INDUSTRIES LLC, BURLINGTON INDUSTRIES V, LLC, BURLINGTON WORLDWIDE INC., CARLISLE FINISHING LLC, CONE ACQUISITION LLC, CONE ADMINISTRATIVE AND SALES LLC, CONE DENIM LLC, CONE DENIM WHITE OAK LLC, CONE INTERNATIONAL HOLDINGS, INC., CONE INTERNATIONAL HOLDINGS II, INC., CONE JACQUARDS LLC, INTERNATIONAL TEXTILE GROUP ACQUISITION GROUP LLC, SAFETY COMPONENTS FABRIC TECHNOLOGIES, INC., WLR CONE MILLS IP, INC., VALENTEC WELLS, LLC and NARRICOT INDUSTRIES LLC (each, a “Grantor” and, collectively, the “Grantors”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

RECITALS

A. WHEREAS, the Grantors have, pursuant to that certain Trademark Security Agreement, dated as of December 24, 2008 and filed with the United States Patent and Trademark Office on December 30, 2008, (a) at Reel 3911, Frame 0280, (b) at Reel 3911, Frame 0342, (c) at Reel 3911, Frame 0368 and (d) at Reel 3911, Frame 0449 (the “Trademark Security Agreement”), granted to Agent a security interest in and to all of each Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Agent wishes to terminate and release, without representation or warranty, its security interest in and to the Released Collateral as provided in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby terminates and releases, without representation or warranty, its security interest in and to the Released Collateral and terminates the Trademark Security Agreement. Agent acknowledges that this Release may be filed along with any other necessary documentation with the United States Patent and Trademark Office (the “USPTO”) or any other governmental office to evidence the release granted herein at the sole expense of the Grantors. Agent authorizes the Grantors to record this Release with the USPTO and other applicable registry at the sole expense of the Grantors and agrees to provide the Grantors with any information and additional authorization necessary to effect the release of Agent’s security interest in the Released Collateral.


