RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (this "Release") is made as of November 2, 2016, by SJC DLF II-H, LLC (the "Agent"), acting in its capacity as the lender party to (a) that certain Loan and Security Agreement dated as of December 24, 2014 (the "Loan Agreement"), by and among Focus Products Group International, LLC, an Illinois limited liability company, Sure Fit Inc., a Delaware corporation, Sure Fit Outdoor LLC, a Delaware limited liability company, and Lloyd Industries, Inc., a Washington corporation, as borrowers (collectively, the "Borrowers"), and CLP FPG, Inc., a Delaware corporation, and Manpans, LLC, a Washington limited liability company, as guarantors (the "Guarantors" and collectively with the Borrowers, the "Obligors"), the financial institutions from time to time party thereto and the Agent, as term loan lender; and (b) that certain Trademark Security Agreement and that certain Patent Security Agreement, each dated as of December 24, 2014, among the Obligors, as grantors, and the Agent, as lender (collectively, the "Security Agreements"). Terms used but not defined in this Release shall have the meanings given thereto in the Loan Agreement and/or the Security Agreements.

WHEREAS, pursuant to the Security Agreements, the Agent was granted a security interest in and to the Trademark Collateral, including the Trademarks listed on Schedule A (the "Subject Trademarks"), and the Patent Collateral, including the Patents listed on Schedule B (the "Subject Patents"); and

WHEREAS, the Obligors have requested that the Agent terminate and release its security interests in and to the Subject Trademarks and the Subject Patents, and that the Agent execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office ("USPTO"); and

WHEREAS, the Agent has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby releases and terminates all security interests and other interests it may have in the Subject Trademarks and the Subject Patents. Obligors or the relevant assignee and current owner of all right, title and interest in the Subject Trademarks and Subject Patents are authorized to file this Release with the USPTO and any other governmental authority.


The delivery of an executed counterpart of a signature page to this Release by facsimile shall be effective as delivery of a manually executed counterpart of this Release. The validity, construction and effect of this Release shall be governed by the internal laws of the State of New York (without giving effect to its principles of conflicts of law) and shall relate solely to the Security Agreements.
