**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this "Trademark Assignment") is made as of October 31, 2016, by and between Evoshield, LLC, a Delaware limited liability company, having a principal place of business at 300 Commerce Blvd., Athens, GA 30606 ("Assignor"), and Wilson Sporting Goods Co., a Delaware corporation, having a principal place of business at 8750 W. Bryn Mawr Ave., Chicago, Illinois 60631 ("Assignee").

WHEREAS, Assignor and Assignee are parties to an Assignment and Assumption of Intellectual Property entered into on October 31, 2016, pursuant to which Assignor agreed to transfer to Assignee all right, title, and interest in and to the trademarks identified on the attached Schedule 1(f) (the "Marks"); and

Assignor hereby authorizes the appropriate empowered officials at the United States Patent and Trademark Office, and at trademark offices in countries outside of the United States, to transfer all registrations and pending applications for the Marks to Assignee as assignee of the entire right, title and interest therein or otherwise as Assignee may direct, in accordance with this instrument of assignment. With respect to the U.S. Trademarks, to the extent that an application for any Mark is based on intent-to-use and no allegation of use under Section 1(c) or 1(d) of the Lanham Act has been filed for such application, Assignor is assigning each such Mark and accompanying application as part of the entire business or portion thereof to which the Mark pertains as required by Section 10 of the Lanham Act.

2. Counterparts. This Trademark Assignment may be signed in counterparts, which together shall constitute one agreement. If this Trademark Assignment is signed in counterparts, no party shall be bound until both parties have duly executed, or caused to be duly executed, a counterpart of this Trademark Assignment.

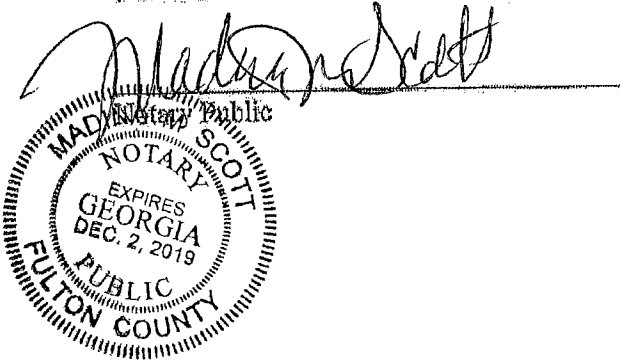

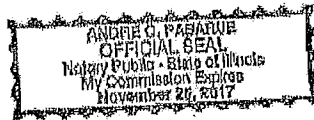
