## RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of July 11, 2014 (the “Effective Date”), by **CYPRIMUM INVESTORS III LP**, a Delaware limited partnership and formerly known as KPP Investors III LP (“KPP I”), **KEY PRINCIPAL PARTNERS IIIA LLC**, an Ohio limited liability company (“KPP II”), and **CYPRIMUM INTERNATIONAL INVESTORS III LP**, a Delaware limited partnership and formerly known as KPP International Investors III LP (“KPP III” and together with KPP I and KPP II, the “Grantees”), in favor of **HOBBICO, INC.**, an Illinois corporation (“Hobbico”), **TOWER HOBBIES, INC.**, an Illinois corporation and wholly-owned subsidiary of Hobbico (“Tower”), **GREAT PLANES MODEL MANUFACTURING, INC.**, an Illinois corporation and wholly-owned subsidiary of Hobbico (“Great Planes”), **UNITED MODEL, INC.**, an Illinois corporation and wholly-owned subsidiary of Hobbico (“United Model”), **REVELL INC.**, an Illinois corporation and wholly-owned subsidiary of Hobbico (“Revell”), **ESTES-COX CORP.**, a Delaware corporation and wholly-owned subsidiary of Hobbico (“EC”), and **AXIAL R/C INC.**, a California corporation and wholly-owned subsidiary of Hobbico (“Axial” and together with Hobbico, Tower, Great Planes, United Model and Revell, the “Grantors”).

### WITNESSETH:

**WHEREAS**, in connection with that certain Securities Purchase Agreement, dated as of December 22, 2010 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among Grantors and Grantees, Grantors executed and delivered that certain Trademark Security Agreement, dated as of December 22, 2010 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”);

**WHEREAS**, pursuant to the Trademark Security Agreement, each Grantor granted to Grantees a continuing security interest in all of such Grantor’s then owned or existing or thereafter acquired or arising: (a) trademarks, registered trademarks, trademark applications, trade names, trade styles, service marks, registered service marks, internet domain names and service mark applications, including, without limitation, the trademarks, registered trademarks, trademark applications, trade names, trade styles, service marks, registered service marks, internet domain names and service mark applications listed on Schedule A, and (i) all renewals thereof, (ii) all income, royalties, damages and payments now or hereafter due and/or payable under and with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements or dilutions thereof, (iv) the goodwill of each Grantor’s business symbolized by the foregoing and connected therewith and (v) all of each Grantor’s rights corresponding thereto throughout the world (all of the foregoing are sometimes hereinafter individually and/or collectively referred to as the “Trademarks”); and (b) rights under or interests in any trademark license agreements or service mark license agreements with any other party in connection with any of the Trademarks or such other party’s trademarks and registered trademarks, trademark applications, service marks, registered service marks, service mark applications, trade names and trade styles, to the extent such rights are assignable pursuant to such trademark license agreements or service mark license agreement without invalidating such agreements, whether any Grantor is a licensor or licensee under any such license agreement, including without limitation, those license agreements listed on Schedule B, and the right, upon the occurrence and during the continuation of an Event of Default, to prepare and sell any and all inventory then or thereafter owned by such Grantor and then or thereafter covered by such licenses, and all books and all records (including, without limitation, customer lists, credit files, computer programs, printouts and other computer materials and records) pertaining to any of the foregoing (all of the foregoing are hereinafter referred to collectively as the “Licenses,” and together with the Trademarks, the “Trademark Collateral”);



**WHEREAS**, the Trademark Security Agreement was recorded with The United States Patent and Trademark Office at Reel 4444/Frame 0708 on December 22, 2010; and

**WHEREAS**, Grantees desire to release their lien on and continuing security interest in and to all of the right, title, and interest of each Grantor in the Trademark Collateral.

**NOW, THEREFORE**, in consideration of the foregoing and other good and valuable consideration, receipt, and sufficiency of which are hereby acknowledged, each Grantee hereby releases, relinquishes and discharges, with respect to each Grantor, all of its security interest in all such Grantor's right, title, and interest in, to and under the Trademark Collateral, and re-assigns to such Grantor any and all right, title or interest such Grantee may have in the Trademark Collateral, all without warranty or representation of any kind.

Each Grantee hereby authorizes any Grantor, or Grantors' authorized representatives to: (a) record this Release with The United States Patent and Trademark Office and/or any other applicable governmental office or agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the lien on and security interest of each Grantee in the Trademark Collateral.





**Hobbico, Inc**  
**Licensing Agreements as of December 17, 2010**

**Hobbico, Inc. and Patty Wagstaff** dated November 8, 2001 for a term of three years with automatic renewal terms of three years unless written notice is given by either party sixty (60) days prior to the expiration of the term. Hobbico currently manufactures and sells an aircraft using all of the distinguishing characteristics of Patty Wagstaff's aircraft, including her name and likeness, in exchange for a royalty.

**Hobbico, Inc. and Royce McClure** dated March 15, 2004 for a term of two years, and to renew for terms of one year unless either party notifies the other party of non-renewal at least 60 days prior to the end of the current term. This agreement grants Hobbico the exclusive right to reproduce and market specific works by Royce McClure on puzzles in exchange for a royalty.

**Hobbico, Inc. and Wesley Prints, Inc.** dated August 15, 2006 for a term of three years and to renewed for an additional three years. This agreement grants Hobbico the exclusive right to reproduce and market specific works belonging to Wesley Prints for use on puzzles in exchange for a royalty.

**Hobbico, Inc. and Howard Robinson** dated August 14, 2006 for a term of three years which renewed in September of 2009. This agreement grants Hobbico the right to produce his images on lenticular puzzles in exchange for a royalty.

**Hobbico, Inc. and Tom Cross** dated January 1, 2007 for a term of three years which automatically renewed for a term of two years. This agreement grants Hobbico the right to use several of his images on lenticular puzzles in exchange for a royalty.

**Hobbico, Inc. and Alan Giana** dated August 10, 2007 for a term of three years to expire in December of 2010. This agreement grants Hobbico the right to use his images on puzzles in exchange for a royalty. This agreement will not be renewed.

**Hobbico, Inc. and Michael Flynn** dated May 1, 2007 for a term of two years and which automatically renewed for another term of two years. This agreement grants Hobbico the right to use Doug Laird's images on Hobbico's puzzles in exchange for a royalty.

**Hobbico, Inc. and Ciro Marchetti** dated May 23, 2007 for a term of two years with an automatic two year renewal. This agreement grants Hobbico the right to use Ciro Marchetti's images on Hobbico's puzzles in exchange for a royalty.

**Hobbico, Inc. and Lori Schory** dated August 15, 2007 for a term of two years with an automatic renewal of one, two year term. This agreement grants Hobbico the right to use Lori Schory's images on puzzles in exchange for a royalty.

**Hobbico and Lockheed Martin Corporation** dated June 1, 2006 for a term of three years and amended in June of 2009 for an additional term of three years whereby Hobbico has the right to manufacture and sell certain products bearing the licensed marks which are the property of Lockheed Martin Corporation.

**Hobbico and Textron Innovations, Inc.** dated August 26, 2005 and effective November 1<sup>st</sup> 2004 through December 31, 2007 whereby Hobbico has the right to manufacture and sell certain products bearing the licensed marks which are the property of Textron Innovations and amended in February of 2010 for an additional term of three years to expire in February of 2013.

**Hobbico, Inc. and Aviat Aircraft** - dated October 1, 2009 for a term of one year with automatic renewals of one year to allow Hobbico to manufacture and sell replicas of Aviat's Python aircraft in exchange for a royalty. Addendum signed July 1, 2010 to allow Hobbico to sell replicas of the Christen Eagle for an annual fee.

**Hobbico, Inc. and Cirrus Design Corporation** - dated October 1, 2009 giving Hobbico the right to manufacture and sell radio control versions of certain Cirrus products. This agreement has no specific term and is royalty free.

**Hobbico, Inc. and Austin Dunn** - dated September 1, 2009 giving Hobbico the right to sell products designed by Austin Dunn in exchange for a 3% royalty. The term is perpetual unless terminated by Hobbico at any time upon sixty (60) days written notice.

**Hobbico, Inc. and the Boy Scouts of America** - dated February 24, 2010 for a term of three (3) years giving Hobbico the right to manufacture and sell certain BSA licensed products in exchange for a royalty.

**Hobbico, Inc. and R&R Sportworks** - dated October 7, 2010 for a term of three years and renewed upon mutual agreement, giving Hobbico the exclusive right to manufacture and sell an R/C version of the Motley Crew catamaran in exchange for a royalty.




