RELEASE AND TERMINATION OF SECURITY INTEREST

WHEREAS, LVMH Moet Hennessy Louis Vuitton Inc., a Delaware corporation, ("LVMH"), and Gabrielle Studio, Inc., a New York corporation ("Gabrielle") are parties to a Trademark Security Agreement dated November 27, 2001 (the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was executed purusant to certain agreements, collectively defined in the Trademark Security Agreement as "Agreements", and the terms of said Agreements were incorporated by reference into the Trademark Security Agreement;

WHEREAS, pursuant to the Trademark Security Agreement, Gabrielle granted to LVMH a security interest in "Collateral", as defined in the Trademark Security Agreement, including, without limitation, the United States trademarks, trademark registrations, and trademark applications owned by Gabrielle, set forth in Exhibit A;

WHEREAS, LVMH recorded the Trademark Security Agreement with the U.S. Patent and Trademark Office Assignment Branch on November 29, 2001, at Reel 2400, Frame 0779; and

WHEREAS, LVMH now desires to terminate and release the entirety of its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Trademark Security Agreement and the Agreements, the receipt and sufficiency of which is hereby acknowledged, and upon the terms set forth in this Release and Termination, LVMH hereby states as follows:

- 1. <u>Definitions</u>. The terms "Collateral" and "Agreements" as used in this Release and Termination have the same meanings as in the Trademark Security Agreement.
- 2. <u>Release of Security Interest</u>. LVMH hereby terminates, releases and discharges its security interest in the Collateral under the Trademark Security Agreement and the Agreements, and any right, title or interest of LVMH in such Collateral shall hereby cease and become void.
- 3. <u>Further Assurances</u>. LVMH hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
- 4. <u>Governing Law</u>. This Release and Termination shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
