

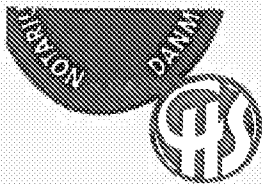

TRADEMARK ASSIGNMENT

WHEREAS, Carl Hansen & Son Mobelfabrik A/S, a corporation organized under the laws of Denmark, having a place of business at Hylkedamvej 77 – 79, Lunge Bjerger, 5591 Gelsted, Denmark (“Assignor”), is the owner of all right, title, and interest in and to the trademark WISHBONE for chairs (the “Trademark”), U.S. Trademark Registration No. 3,640,043 for the Trademark (the “Registration”), and the goodwill of the business symbolized by the Trademark (collectively, the “Trademark Assets”); and

WHEREAS, Hans J Wegners Tegnesteue I/S, a partnership organized under the laws of Denmark, having a place of business at Tinglevvej 17, DK-2820 Gentofte, Denmark (“Assignee”) is desirous of acquiring the Trademark Assets;

WHEREAS, the assignment of the Registration shall be made of record in the United States Patent and Trademark Office; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee, free and clear of all liens and encumbrances, (i) all of Assignor’s right, title and interest in and to the Trademark Assets, including the goodwill of the business symbolized thereby; (ii) any and all legal actions and rights and remedies at law or in equity for past, present or future infringements, dilutions, or other violations of the Trademark Assets, including the right to sue for, collect, and retain all damages, profits, proceeds, and all other remedies associated therewith; and (iii) any and all income, royalties, damages, and payments now or hereafter due or payable with respect to the Trademark Assets, for Assignee’s own use and enjoyment and for the use and enjoyment of



Assignee's successors, assigns, or other legal representatives as fully and entirely as the same would have been enjoyed by Assignor if this Assignment has not been made.

Assignor agrees that it will execute or arrange for execution and will deliver or cause to be delivered to Assignee such further assignment documents or other legal instruments as may be necessary or requested by Assignee to permit Assignee to obtain recordation of the assignment of the Trademark Assets from Assignor to Assignee and to complete the timely transfer of the Trademark Assets from Assignor to Assignee.

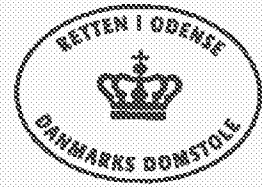


