**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This Release, effective as of November 18, 2016, is granted by Deutsche Bank Trust Company Americas, a New York banking corporation, with its principal office at 60 Wall Street, New York, NY 10005 to Gunito Corporation, a Delaware corporation (the "Grantor"), with its principal office at 7140 Office Circle, Evansville, IN 47715, as follows:

WITNESSETH

WHEREAS, the Grantor has heretofore granted to Deutsche Bank Trust Company Americas as notes priority collateral agent ("Notes Priority Collateral Agent") a security interest in certain trademark registrations and applications for trademark registrations and the goodwill associated therewith, patents and patent applications, copyright registrations and applications, and other intellectual property as set forth on Schedule A attached hereto (the "Intellectual Property") pursuant to that certain Security Agreement dated as of July 29, 2010 by the Grantor and other grantors listed therein in favor of the Notes Priority Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time the "Security Agreement") and that certain Intellectual Property Security Agreement, dated as of July 29, 2010 (the "IP Security Agreement") and recorded (i) with the United States Patent and Trademark Office on July 30, 2010 at Reel/Frame No. 4251/0493, and on July 30, 2010 at Reel/Frame No. 024767/0329 and (ii) with the United States Copyright Office on September 2, 2010 at V3593 D883; and


WHEREAS, the Notes Priority Collateral Agent wishes to release and restore all right, title and interest in and to the Intellectual Property to the Grantor and to dissolve any and all liens and encumbrances respecting the Intellectual Property under the Security Agreement and the IP Security Agreement.


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Notes Priority Collateral Agent, without recourse and without representation or warranty of any kind (either express or implied), hereby terminates releases, retransfers, reassigns, forever discharges, quit claims and relinquishes unto the Grantor the security interest in the Intellectual Property set forth on Schedule A.
