TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Assignment") effective as of **May, 16 2016** (the "Effective Date"), is by and between **ITT Manufacturing Enterprises LLC**, a corporation organized under the laws of the State of Delaware having offices at 1105 North Market Street, Wilmington, Delaware 19801 (the "Assignee") and **ITT Corporation**, a corporation organized under the laws of the State of Indiana having offices at 1133 Westchester Avenue, White Plains NY 10604 ("Assignor");

WHEREAS, in connection with the transactions contemplated by the Asset Purchase Agreement, dated as of May 16, 2016, among **ITT LLC and ITT Holding LLC**. (the "Asset Purchase Agreement"), Assignor wishes to assign to Assignee the trademarks listed on Schedule A annexed hereto;

WHEREAS, this Assignment is an assignment that must be executed pursuant to Section 2.1(c) of the Asset Purchase Agreement.

NOW, THEREFORE, in consideration of the promises and of the mutual covenants and agreements herein contained, and for good and valuable consideration, including that recited in the Distribution Agreement, the receipt and adequacy of which is acknowledged by the parties, the parties agree as follows:

1. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the trademarks listed on Schedule A hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby, the registrations and applications for registration thereof and rights of renewal and extension thereof, claiming priority or seniority thereon, all common-law rights related thereto and all causes of action and rights of recovery for infringements, dilutions or violations of the foregoing prior to the Effective Date (the "Trademarks").

2. Each party acknowledges that (i) this Assignment is a legal, valid and binding obligation of the warranting party, (ii) it has full power and authority to enter into and perform its obligations under this Assignment in accordance with its terms, (iii) the representations and warranties contained in the Distribution Agreement are the only representations and warranties made with respect to the Trademarks, and (iv) except as may be set forth in the Distribution Agreement, the Trademarks are being assigned, transferred and conveyed "as is."

3. The right, title and interest in and to each of the Trademarks are to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as they would have been held and enjoyed by Assignor had this assignment not been made.

4. This Agreement shall be effective as between the parties as of the Effective Date. Assignee shall be responsible for any filings, fees or other expenses that may arise in connection with this Assignment, including any filings, fees and expenses required to record,

perfect, validate or effectuate this Assignment in the United States Patent and Trademark Office or any other applicable office in any applicable foreign jurisdiction.

5. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which shall, taken together, be considered one and the same agreement.

6. This Assignment shall be governed and construed in accordance with the laws of the State of New York. This Agreement may be executed in counterparts.


