## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), dated as of December 14, 2016, confirms the termination and release of the security interest granted to GE Business Financial Services Inc. f/k/a Merrill Lynch Business Financial Services Inc. ("GE") as set forth hereunder.

WHEREAS, Nat Sherman, Inc., a New York corporation, ("Nat Sherman") and GE, in connection with that certain Loan and Security Agreement, dated as of December 16, 1999 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), were parties to a certain Patent, Trademark and License Mortgage dated as of December 16, 1999 ("IP Security Agreement");

WHEREAS, Nat Sherman, pursuant to the Loan Agreement and the IP Security Agreement, has granted GE a security interest in certain intellectual property, including the trademarks and registrations therefor as set forth in **Exhibit A** attached hereto (collectively, without limitation, "Trademark Properties");

WHEREAS, the IP Security Agreement was recorded in the U.S. Patent and Trademark Office on January 18, 2000, at Reel 2022, Frames 702-711;

WHEREAS, Nat Sherman repaid the Obligations (as defined in the Loan Agreement) in full prior to the date hereof; and

WHEREAS, this Release is intended to confirm the release and termination of all liens, security interests, and other encumbrances in and to the Trademark Properties created under the Security Agreement in favor of GE.

NOW, THEREFORE, pursuant to the terms of the IP Security Agreement:

1. This Release confirms that the entire security interest and all other rights and interests granted to GE under the IP Security Agreement in and to the intellectual property and other assets of Nat Sherman, including without limitation, the Trademark Properties listed in **Exhibit A** attached hereto, are released and permanently terminated to the extent that any security interest was granted to GE by the IP Security Agreement.

2. This Release is intended to be recorded in the U.S. Patent and Trademark Office or any other trademark office(s) as desired to confirm and evidence the foregoing release and termination of the security interest and rights created under the IP Security Agreement.

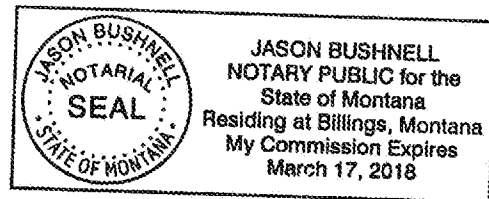
