(the "Borrower"), and the other Persons listed on the signature pages hereof (the Borrower and the other Persons being collectively referred to herein as the "Grantors", and individually as a "Grantor"), now own or hold and may hereafter adopt, acquire or hold Trademarks (defined as all of the following: all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade dress, logos, other source of business identifiers and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof or similar property rights, and all applications based on actual use of any such mark, design, logo, or name in connection therewith, including, without limitation, the registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof listed on Schedule A annexed hereto, and all reissues, extensions or renewals thereof), as such Schedule may be amended from time to time by the addition of Trademarks subsequently registered or otherwise adopted or acquired;

WHEREAS, the Grantors, JPMorgan Chase Bank, N.A. (the "<u>Administrative Agent</u>"), as administrative agent for the banks and other financial institutions or entities (the "<u>Lenders</u>") from time to time parties thereto, and the other parties set forth therein have entered into a Credit and Guarantee Agreement dated as of December 8, 2016 (as it may be amended or modified from time to time, the "<u>Credit Agreement</u>");

WHEREAS, the Grantors and the Administrative Agent have entered into a Pledge and Security Agreement, dated as of December 8, 2016 (as it may be amended or modified from time to time, the "Security Agreement"), to secure the payment and performance of the Obligations (capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement or the Credit Agreement, as applicable); and

WHEREAS, each Grantor is entering into this Trademark Security Agreement in order to induce the Lenders to enter into and extend credit to the Borrower under the Credit Agreement and to secure the Obligations;

NOW THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

Each of the Grantors do hereby grant to the Administrative Agent for the benefit of the Secured Parties, as security for the Obligations, a continuing security interest in all of the Grantors' right, title and interest in, to and under the following (all of the following items or types of property being collectively referred to herein as the "Trademark Collateral"), wherever located or situated and whether now owned, presently existing or hereafter acquired or created:

(a) each Trademark and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, including, without limitation, each Trademark referred to in Schedule A annexed hereto, and all rights to sue for past, present, and future infringements thereof;

(b) any and all Trademark licensing agreements or similar arrangements in and to such Grantor's Trademark, all income, royalties, damages, claims, and payments now or hereafter due or payable under and with respect thereto, including, without limitation, damages and payments for past, present and future breaches thereof, and all rights to sue for past, present, and future breaches thereof

provided, in each case, that the Trademark Collateral shall not include any Excluded Assets.

This security interest is granted in furtherance, and not in limitation, of the security interests granted to the Administrative Agent for the benefit of the Secured Parties pursuant to the Security Agreement. Each Grantor and the Administrative Agent hereby further acknowledges and affirms that the rights and remedies of the Administrative Agent for the benefit of the Secured Parties, with respect to the security interest made and granted hereby, are more fully set forth in the Security Agreement and are subject to the limitations (including certain rights of quiet enjoyment in favor of licenses) set forth therein, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

This Trademark Security Agreement is made for collateral purposes only. The security interest created hereby as to any or all of the Trademark Collateral shall be promptly released as contemplated and/or required by the Security Agreement.

Subject to the terms and conditions of the Security Agreement, the Administrative Agent (on behalf of the Secured Parties) agrees that there will be no assignment of the Trademark Collateral, other than the security interest described herein, unless and until there shall occur and be continuing an Event of Default and the Administrative Agent gives written notice to the Grantors of its intention to enforce its rights against any of the Trademark Collateral.

Except as expressly provided in the Security Agreement, each of the Grantors may use, license and exploit the Trademark Collateral in any lawful manner permitted under the Security Agreement and the other Fundamental Documents.

THIS TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH, AND GOVERNED BY, THE LAWS OF THE STATE OF NEW YORK APPLICABLE TO CONTRACTS MADE AND TO BE PERFORMED WHOLLY WITHIN THE STATE OF NEW YORK.

In the event of any conflict between this Trademark Security Agreement and any Intercreditor Agreement, such Intercreditor Agreement shall govern. In the event of any conflict between this Trademark Security Agreement, on the one hand, and the Security Agreement or Credit Agreement, on the other hand, the Security Agreement or Credit Agreement, as applicable, shall govern.

Notwithstanding anything to the contrary contained herein or any other Fundamental Document or otherwise, the Liens and security interests granted pursuant hereto or under any other Collateral Document shall be subject and subordinate to any and all Liens or security interests in favor of any guilds or unions (including, without limitation, the Screen Actors Guild, the American Federation of Television and Radio Artists, the Alliance of Canadian Cinema, Television and Radio Artists, the American Federation of Musicians, the Alliance Quebecoise des Techniciens de l'Image et du Son, the Directors Guild of America, the Directors Guild of Canada, the International Alliance of Theatrical Stage Employees, the National Association of Broadcast Employees and Technicians, the Union of British Columbia Performers, the Writers Guild of Canada, and the Writers Guild of America (each, a "Guild")) incurred pursuant to collective bargaining agreements therewith. The Administrative

Agent and each of the other parties hereto hereby acknowledge and agree that each Guild is an express third party beneficiary of, and shall be entitled to rely on and enforce, this paragraph.

For the avoidance of doubt, as contemplated by the Security Agreement, notwithstanding anything to the contrary contained herein or any other Fundamental Document or otherwise, the Liens and security interests granted pursuant hereto or under any other Collateral Document shall not include trademark applications filed based on an intent to use the trademark, logo, design, or name. However, once the Grantors file a statement of use or amendment to allege use for any such application, the Liens and security interests granted shall then apply to those amended applications.
