## Details

This Deed of Assignment dated 2nd day of November 2016.

Between:

- 1) **INGCO TOOLS CO., LIMITED (Assignor)** 2ND FLOOR, ABBOTT BUILDING, ROAD TOWN TORTOLA, BRITISH VIRGIN ISLANDS
- 2) **SUZHOU DAKE MACHINERY CO., LTD (Assignee)** of ROOM 618, BUILDING NUMBER 1, LUCKY CITY COMMERCIAL CENTER, SUZHOU INDUSTRIAL PARK, SUZHOU CITY, JIANGSU PROVINCE, CHINA

Whereas:

- A. The Assignor owns the Intellectual Property, the full details of which are described in the attached Schedule 1.
- B. The Assignor wishes to assign the Intellectual Property and all its rights and benefit to the Assignee for a fee of **US\$1** and such other consideration which this Agreement may provide.

## Agreed Terms

It is hereby agreed as follows:

1. The Assignor is the sole legal and beneficial owner of all rights, title and interest in the Intellectual Property and is fully entitled to sell, transfer and assign such rights, title and interest as it wishes without requiring the consent of any person.
2. The Assignor hereby sells, assigns and transfers to the Assignee all of its respective rights, title and interest in the Intellectual Property the full details of which are described in the attached Schedule 1.
3. Upon execution of this Agreement, completion of the assignment and payment of the consideration set out above:
  - 3.1 the Assignor relinquishes all rights as defined and provided for under the relevant laws of United States, Australia, New Zealand, Hong Kong, Nepal to the Intellectual Property with the goodwill of the business concerned with the goods associated with the Intellectual Property. The Assignor acknowledges that the Assignee may


subsequently license or assign the Intellectual Property to third parties; and

- 3.2 the Assignor shall transfer to the Assignee without delay all documents relating to and in support of the ownership and title to the Intellectual Property.
4. The Assignor will take whatever action may be necessary, do such further acts and execute and deliver to the Assignee such further instruments as quickly as reasonably possible, so as to allow the Assignee to perfect, register, evidence, or enforce its rights and interest in the Intellectual Property.
5. It is acknowledged that the Assignee will apply to the Registrar of USPTO, to the IP Australia, to the IP Office of New Zealand, to the IP Department of Hong Kong and to the IP Office of Nepal to register the transfer of ownership.
6. The Assignor warrants that it has the rights, title and interest to make this assignment.

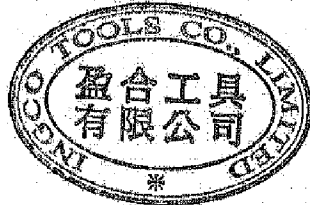



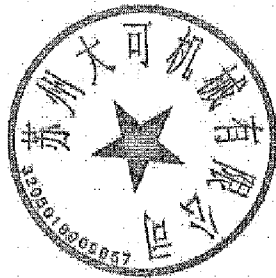
