**RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of December 20, 2016 (the “Effective Date”), is made by Morgan Stanley Senior Funding, Inc., in its capacity as Collateral Agent (the “Collateral Agent”), in favor of the pledgors identified on the signature page hereto (the “Pledgors”).

WHEREAS, pursuant to that certain First Lien U.S. Security Agreement, dated as of February 26, 2014, by and among the Collateral Agent, certain of the Pledgors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “U.S. Security Agreement”), certain of the Pledgors granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to that certain First Lien Canadian Security Agreement, dated as of April 11, 2014, by and among the Collateral Agent, certain of the Pledgors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Canadian Security Agreement” and together with the U.S. Security Agreement, the “Security Agreements”), certain of the Pledgors granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreements, certain of the Pledgors executed and delivered a First Lien Trademark Security Agreement, dated as of February 26, 2014 (the “Trademark Security Agreement”) and various other trademark security agreements, instruments and corrective documents, including those set forth on Schedule A, which, in each case, were recorded with the United States Patent and Trademark Office on the dates and at the Reel/Frame numbers identified on Schedule A (the Trademark Security Agreement and such other agreements, instruments and documents, collectively, the “Trademark Security Filings”); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreements or the Trademark Security Filings, as applicable.
2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademarks and trademark applications set forth Schedule A attached hereto, arising under the Security Agreements and the Trademark Security Filings. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Filings, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Pledgors.
3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Filings.
4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments),


reasonably requested by the Pledgors, at the Pledgors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
