## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is made as of November 8, 2016 (“Effective Date”) by Goldman Sachs Bank USA (the “Administrative Agent”), in favor of Good Sam Enterprises, LLC, a Delaware limited liability company, TL Enterprises, LLC, a Delaware limited liability company, Ehlert Publishing Group, LLC, a Delaware limited liability company, and CWI, Inc., a Kentucky corporation (collectively, “Grantors”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Collateral Agreement or the Trademark Security Agreement (as defined below), as applicable.

**WHEREAS**, Grantors, the Administrative Agent, CWGS Group, LLC (the “Borrower”) and the other parties thereto entered into that certain Collateral Agreement dated November 20, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), which required the parties to enter into the Trademark Security Agreement (defined below);

**WHEREAS**, Grantors and the Administrative Agent entered into that certain Trademark Security Agreement, dated November 20, 2013 (the “Trademark Security Agreement”), under which each Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under the trademarks and trademark applications listed on Schedule I attached hereto, including all Proceeds and products thereof and all rights to sue for past, present and future infringements, misappropriations or violations thereof (collectively, the “Trademark Collateral”); and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 17, 2013, at Reel 5175, Frame 0262;

**WHEREAS**, pursuant to the payoff letter dated as of November [8], 2016, between the Borrower and the Administrative Agent, the Administrative Agent has agreed to take actions reasonably necessary to release and terminate any and all security interests it may have in the Trademark Collateral pursuant to the Loan Documents, and Grantors hereby request a specific release of the Security Interest granted and recorded against the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Trademark Security Agreement, (ii) releases any and all Security Interests or other liens, security interests, right, title and interest the Administrative Agent or any Secured Parties may have in, to or under the Trademark Collateral pursuant to the Trademark Security Agreement and the other Loan Documents, and (iii) re-assigns to Grantors, any right, title or interest the Administrative Agent or any Secured Parties may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby, in each case pursuant to the Trademark Security Agreement and the other Loan Documents.


