**TERMINATION OF TRADEMARK SECURITY

This TERMINATION OF TRADEMARK SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of December 6, 2016, is made by and among Bank of America, N.A., successor by merger to LaSalle Bank National Association, successor by merger to LaSalle Business Credit, Inc., as collateral agent ("Collateral Agent"), in favor of Dunn-Edwards Corporation (the "Grantor") as follows:

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Collateral Agent; and


