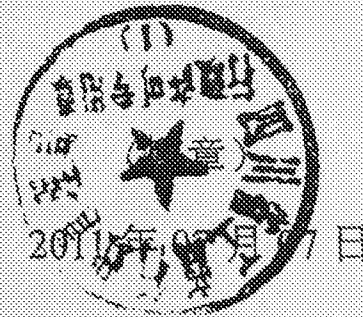

**ASSIGNMENT**

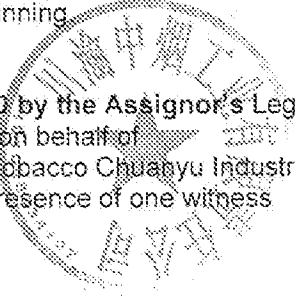

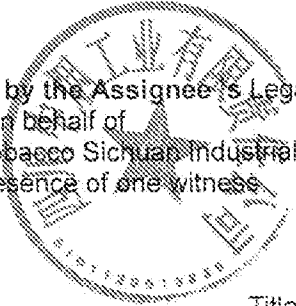
