TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE, dated as of December 22, 2016, from DEUTSCHE BANK AG NEW YORK BRANCH, having a place of business at 60 Wall Street (NYC60-0266), New York, New York 10005-2836, as Collateral Agent (the “Agent”) under certain of the Loan Documents for the Secured Parties, to (i) ALLIED TUBE & CONDUIT CORPORATION, a Delaware corporation having a principal place of business at 16100 S. Lathrop Avenue, Harvey, Illinois 60426, (ii) AMERICAN PIPE AND PLASTICS, INC., a New York corporation having a principal place of business at 958 Route 11, Kirkwood, NY 13795, (iii) ATKORE PLASTIC PIPE CORPORATION a Delaware corporation having a principal place of business at 16100 S. Lathrop Avenue, Harvey, Illinois 60426, (iv) FLEXHEAD INDUSTRIES, INC., a Massachusetts corporation having a principal place of business at 272 Duchaine Boulevard, New Bedford, Massachusetts 02745, (v) SPRINKFLEX, LLC, a Massachusetts limited liability company having a principal place of business at 272 Duchaine Boulevard, New Bedford, Massachusetts 02745 (vi) UNISTRUT INTERNATIONAL CORPORATION, a Nevada corporation having a principal place of business at 4205 Elizabeth Street, Wayne, Michigan 48184 and (vii) WPFY, INC., a Delaware corporation having a principal place of business at 272 Duchaine Boulevard, New Bedford, Massachusetts 02745 (each a “Grantor”, and together, the “Grantors”).

Capitalized terms used herein without definition are used as defined in the (i) Second Lien Credit Agreement, dated as of April 9, 2014 (as amended, restated, amended and restated, waived, supplemented or otherwise modified from time to time, together with any agreement extending the maturity of, or restructuring, refunding, refinancing or increasing the Indebtedness under such agreement or successor agreements, the “Second Lien Credit Agreement”) among Atkore International, Inc., a Delaware corporation, as borrower (the “Borrower”), the Agent, as administrative agent, collateral agent and lender and the lenders and other parties thereto from time to time, or (ii) Second Lien Guarantee and Collateral Agreement, dated as of April 9, 2014 (as amended, restated, amended and restated, waived, supplemented or otherwise modified from time to time, the “Second Lien Guarantee and Collateral Agreement”) among Atkore International Holdings Inc., a Delaware corporation, the Borrower, certain of their subsidiaries, including the Grantors, and the Agent.

WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Guarantee and Collateral Agreement made by the Grantors in favor of the Agent, a security interest (the “Security Interest”) was granted by the Grantors to the Agent in certain Trademarks (as hereinafter defined);

WHEREAS, (i) the Notice and Confirmation of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on April 15, 2014, at Reel 5260, Frame 0730, (ii) the Notice and Confirmation of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on December 19, 2014, at Reel 5423, Frame 0250, (iii) the Notice and Confirmation of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on April 15, 2014, at Reel 5260, Frame 0723 (iv) the Notice and Confirmation of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on April 15, 2014, at Reel 5260, Frame 0753, (v) the Notice and Confirmation of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on April 15, 2014, at Reel 5260, Frame 0766, (vi) the Notice and Confirmation of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on April 15, 2014, at Reel 5260, Frame 0739 and (vii) the Notice and Confirmation of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on April 15, 2014, at Reel 5260, Frame 0746; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Second Lien Guarantee and Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Trademarks: The term “Trademarks,” as used herein, shall mean with respect to any Grantor, all of such Grantor’s right, title and interest in and to all United States trademarks, service marks, trade names, trade dress or other indicia of trade origin or business identifiers, trademark and service mark registrations, and applications for trademark or service mark registrations (except for “intent to use” applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Sections 1(c) and 1(d) of said Act has been filed, it being understood and agreed that the carve out in this parenthetical shall be applicable only if and for so long as a grant of a security interest in such intent to use application would invalidate or otherwise jeopardize Grantor’s rights therein), and any renewals thereof, including, without limitation, each registration and application identified in Schedule I hereto, and including, without limitation, (i) the right to sue or otherwise recover for any and all past, present and future infringements or dilutions thereof, (ii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without

limitation, payments under all licenses entered into in connection therewith, and damages and payments for past or future infringements thereof), and (iii) all other rights corresponding thereto and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto in the United States, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress or other indicia of trade origin or business identifiers.

2. Release of Security Interest: The Agent hereby terminates, releases and discharges its Security Interest in the Trademarks, and any right, title or interest of the Agent in such Trademarks shall hereby cease and become void.

3. Further Assurances: The Agent shall, at the Grantors' expense, execute, deliver or acknowledge such instruments or releases to evidence and shall do or cause to be done all other acts reasonably necessary to effect, in each case, as soon as is reasonably practicable, the release of any Collateral permitted to be released pursuant to the Second Lien Credit Agreement.
