

FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS

This Full Release and Reconveyance of Security Interests ("Release") is granted by WILMINGTON TRUST, NATIONAL ASSOCIATION, as term loan agent for the Lenders (as defined in the Security Agreement) ("Term Loan Agent") is made as of December 22, 2016 ("Effective Date"), in favor of WORLD CLASS CORRUGATING LLC, a Delaware limited liability company, NEW STAR METALS INC., a Delaware corporation, CANFIELD COATING LLC, a Delaware limited liability company, MATERIAL SCIENCES CORPORATION, a Delaware corporation, and MATERIAL SCIENCES CORPORATION, ENGINEERED MATERIALS AND SOLUTIONS GROUP, INC., an Illinois corporation (collectively, the "Grantors", and each individually, a "Grantor").

Term Loan Agent hereby authorizes each Grantor to make any such filing with the United States Patent and Trademark Office as may be reasonably determined by each Grantor to be required to record and evidence the termination, cancellation, and release of the security interests in the Intellectual Property (as defined in the Security Agreement), including the trademark registrations referred to in the attached Schedule A.

- 3. Term Loan Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has in, to or against the Intellectual Property (as defined in the Security Agreement), including the trademark registrations referred to in the attached Schedule A.
- 4. This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to any principles of conflicts of law.
