RELEASE OF ABL INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF ABL INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is made as of October 25, 2016, by Bank of America, N.A., a United States banking association, in its capacity as collateral agent (together with its successors in such capacity, the "Collateral Agent") for the benefit of United States Pipe and Foundry Company, LLC, an Alabama limited liability company, Custom Fab, Inc., a Florida corporation, and Griffin Pipe Products Co., LLC, a Delaware limited liability company (the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the IP Security Agreement.

W I T N E S S E T H:

WHEREAS, reference is made to that certain (i) ABL Credit Agreement, dated as of March 13, 2015, among LSF9 Concrete Ltd., LSF9 Concrete Holdings Ltd., and Stardust Finance Holdings, Inc., the other loan parties party thereto, the lenders party thereto, Bank of America, N.A., as administrative agent, and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the "Credit Agreement"); (ii) ABL Guarantee and Collateral Agreement, dated as of March 13, 2015, by LSF9 Concrete Ltd., LSF9 Concrete Holdings Ltd., Stardust Finance Holdings, Inc., the Grantors and the other grantors party thereto, in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the "Guarantee and Collateral Agreement"); and (iii) ABL Intellectual Property Security Agreement, dated as of April 15, 2016, by the Grantors and the other grantors party thereto, in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the "IP Security Agreement") pursuant to which the Grantors have granted to the Collateral Agent for its benefit and the benefit of various other financial institutions, a security interest in the intellectual property set forth on Schedules 1, 2, and 3 hereto (the "IP") and the goodwill of the business symbolized by such IP, and the registrations and applications therefor (together with the IP, the "IP Collateral");

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on June 1, 2016 at Reel 5804 and Frame 0494 for trademarks, and on June 1, 2016 at Reel 038854 and Frame 0922 for patents, and was sent in for recordation on or about June 1, 2016 to the U.S. Copyright Office for copyrights; and

WHEREAS, Grantors have requested that the Collateral Agent release, and the Collateral Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent does hereby terminate, release and discharge the entirety of any and all security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the IP Security Agreement to the IP Collateral and any right, title or interest of the Collateral Agent in such IP Collateral shall hereby terminate, cease and become void. The Collateral Agent hereby assigns, transfers and conveys any and all right, title or interest of the Collateral Agent in the IP Collateral to the Grantors.



3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
