RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of January 4, 2017 ("Effective Date") by and among WILMINGTON TRUST, NATIONAL ASSOCIATION ("Agent"), COREL CORPORATION ("Corel"), a corporation continued under the laws of Canada, and COREL US HOLDINGS, LLC, a Delaware limited liability company ("Corel Subsidiary"), and VAPC (Lux) S.á.r.l. ("VAPC") (Corel, Corel Subsidiary and VAPC, each, individually a "Grantor" and together, collectively, the "Grantors").

WHEREAS, Grantors and Agent have entered into that certain Credit and Security Agreement, dated June 7, 2013 (the "Credit Agreement"), pursuant to which, (i) Corel, Corel Subsidiary and Agent, among others, entered into that certain Intellectual Property Security Agreement dated June 21, 2013 (trademarks recorded with the United States Patent and Trademark Office on June 21, 2013 at Reel 5052 and Frame 0722 and patents recorded with the United States Patent and Trademark Office on June 21, 2013 at Reel 030657 and Frame 0487); as amended by that certain First Amendment to Intellectual Property Security Agreement and Release dated December 8, 2014, (ii) VAPC and Agent entered into that certain Intellectual Property Security Agreement dated June 28, 2013 (recorded with the United States Patent and Trademark Office on June 28, 2013 at Reel 5060 and Frame 0555 and recorded with the United States Copyright Office ("USCO") on July 2, 2013 at Volume 3617 Document Number 657 and (iii) Corel and Agent entered into that certain Intellectual Property Security Agreement dated as of August 8, 2016 (trademarks recorded with the United States Patent and Trademark Office on August 8, 2016 at Reel 5849 and Frame 0020, patents recorded with the United States Patent and Trademark Office on August 8, 2016 at Reel 039369 and Frame 0070 and accepted for recording with the USCO on or about August 26, 2016), (as amended, and together, collectively, the "Security Agreement"). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Credit Agreement.

WHEREAS, pursuant to the terms and conditions of the Security Agreement, Grantors granted to Agent a security interest in and to all of Grantors' right, title and interest in and to all of Grantors' Intellectual Property (including any and all goodwill associated therewith), Copyright Licenses, Trademark Licenses, and Patent Licenses, collectively, the "Intellectual Property Collateral"), including, without limitation, the United States and Canadian Copyrights set forth on Exhibit A attached hereto, the United States and Canadian Patents set forth on Exhibit B attached hereto and the United States and Canadian Trademarks set forth on Exhibit C attached hereto; and

WHEREAS, Grantors have paid all outstanding indebtedness to Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral.

Agent hereby authorizes Grantors or any of its authorized representatives to file this Release with the United States Patent and Trademark Office and the United States Copyright

Office. Agent shall, at Grantors' expense, take all further actions, and provide to Grantors and Grantors' successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantors to more fully and effectively effectuate the purposes of this Release.
