### TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This Termination and Release (this "*Release*") is made with regard to that certain Intellectual Property Security Agreement entered into as of December 23, 2013 (the "*Agreement*") by and between PEPI CAPITAL, L.P., a Delaware limited partnership (the "*Lender*") and TRUPANION, INC., a Delaware corporation (the "*Company*").
