TERMINATION AND RELEASE
(Patent/Trademarks)

This TERMINATION AND RELEASE is dated as of January 9, 2017, and made by PNC BANK, NATIONAL ASSOCIATION (the "Secured Party"), in favor of San Jamar, Inc., a corporation organized under the laws of the State of Wisconsin (the "Pledgor").

WITNESSETH:

WHEREAS, the Pledgor granted a security interest in certain Collateral (as hereinafter defined) to the Secured Party (the "Security Interest"); and

WHEREAS, the Security Interest was recorded with the United States Patent and Trademark Office; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby (i) terminates and releases the Security Interest in the Collateral, (ii) re-assigns to the Pledgor any right, title and interest it may have in, to and under the Collateral and (iii) authorizes the Pledgor or Pledgor's authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release.

1. The term "Collateral," as used herein, shall mean all of Pledgor's right, title and interest of every kind and nature in the trademarks and service marks set forth on Schedule A attached hereto, the patents set forth on Schedule B attached hereto and (i) all registrations, applications, recordings and common-law rights relating thereto; (ii) all reissues, continuations, continuations-in-part or extensions thereof/ all renewals thereof; (iii) all income, license royalties, damages and payments now and hereafter due and/or receivable with respect thereto, including, without limitation, all damages and payments receivable for past, present and/or future infringements thereof; (iv) the right to sue for past, present and/or future infringements thereof; (v) all rights corresponding thereto throughout the world; and (vi) the goodwill of the Pledgor's business connected with or symbolized by the foregoing.




