
For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank of America, N.A., as Collateral Agent (the "Collateral Agent"), pursuant to the Sixth Restated Security Agreement dated as of July 7, 2015, by and among Nexstar Broadcasting, Inc. (the "Grantor") and the Collateral Agent (such agreement, together with all amendments, supplements, modifications and restatements thereto, the "Security Agreement"), does hereby (a) terminate and release any and all of its liens, security interests, right, title and interest in and to (i) all of the Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all of the Grantor's right, title and interest in and to the United States patents (the "Patents") set forth on Schedule B attached hereto, in each case together with (iii) all Proceeds (as such term is defined in the Security Agreement) and products of the Marks and Patents, (iv) the goodwill of the businesses with which the Marks are associated and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same (the "Released Collateral"), arising from that certain Security Agreement, which was recorded in the United States Patent and Trademark Office on or about February 12, 2016, as against the Released Collateral at Reel/Frame 037820-0001 (the "Security Agreement"), (b) terminates the Security Agreement, and (c) re-assigns to Grantor, any right, title or interest the Collateral Agent may have in, to or under the Released Collateral, together with the goodwill of the business symbolized thereby.

This document shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York. Executed as of the 17th day of January, 2017.
