(iii) all copyrights and copyright applications and all issuances, extensions and renewals thereof, and

(iv) all Internet domain name registrations and applications and all renewals thereof,

(v) all priority rights of any of the foregoing under the International Convention for the Protection of Industrial Property for every member country, and

(vi) all claims and causes of action, and rights thereto, with respect to any of the foregoing, whether accruing before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages; and


