TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, this "Trademark Security Agreement") dated February 3, 2017, is made by BJ's Wholesale Club, Inc., a Delaware corporation (the "Grantors") in favor of Wells Fargo Bank, National Association, as administrative agent (the "Administrative Agent") for the benefit of the Secured Parties (as defined in the Credit Agreement referred to below).

Whereas, reference is made to (i) the Credit Agreement, dated as of September 30, 2011 (as amended and in effect immediately prior to the Credit Agreement referred to below, the "Existing Credit Agreement"), by and among BJ's Wholesale Club, Inc., a Delaware corporation (the "Borrower"), Beacon Holding Inc., a Delaware corporation ("Holdings"), the lenders and issuers party thereto from time to time, and the Administrative Agent (as successor in such capacity by appointment and assignment to General Electric Capital Corporation), pursuant to which the lenders have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Existing Credit Agreement, the issuers have agreed to issue letters of credit for the account of the Borrower or a Restricted Subsidiary on the terms and conditions set forth in the Existing Credit Agreement, and (ii) the Trademark Security Agreement, dated as of September 30, 2011, by and between the Borrower (as successor by merger to Strathmore Partners LP) and the Administrative Agent (as successor in such capacity by appointment and assignment to General Electric Capital Corporation), which was recorded at the US Patent and Trademark Office at Reel 4633, Frame 0404 (the "Existing Trademark Security Agreement").

Whereas, reference is made to (i) the Amended and Restated Credit Agreement, dated as of February 3, 2017 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Credit Agreement"), by and among the Borrower, Holdings, the Lenders and Issuers party thereto from time to time, and the Administrative Agent, (ii) each Secured Hedge Agreement, and (iii) each agreement relating to Cash Management Services.

Whereas, the Lenders have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement, the Issuers have agreed to issue Letters of Credit for the account of the Borrower or a Restricted Subsidiary on the terms and conditions set forth in the Credit Agreement, the Hedge Banks have agreed to enter into and/or maintain one or more Secured Hedge Agreements and the Cash Management Banks have agreed to enter into and/or maintain Cash Management Services, on the terms and conditions set forth in the Credit Agreement, in such Secured Hedge Agreements or agreements relating to Cash Management Services, as applicable.

Whereas, as a condition precedent to the Lenders extension of such credit, the obligation of the Hedge Banks to enter into and/or maintain such Secured Hedge Agreements and the obligation of the Cash Management Banks to enter into and/or maintain such Cash Management Services, Grantor has executed and delivered that certain Amended and Restated Security Agreement dated February 3, 2017, made by the Grantors to the Administrative Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement").

Whereas, under the terms of the Security Agreement, the Grantor has granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantor, and has agreed as a condition thereof to execute this Trademark Security Agreement for recording with the U.S. Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor agrees as follows:

SECTION 1. Terms. Terms defined in the Credit Agreement and Security Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement and Security Agreement.

SECTION 2. Grant of Security. The Grantor hereby grants to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties a continuing security interest in all of the Grantor's right, title and interest in, to and under the Trademarks, including the Trademarks set forth on Schedule A attached hereto; provided, that, in no event shall any security interest be granted in any "intent-to-use" application for registration of a Trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a "Statement of Use" pursuant to Section 1(d) of the Lanham Act or an "Amendment to Allege Use" pursuant to Section 1(c) of the Lanham Act with respect thereto, to the extent that, and during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law (it being understood that after such period such intent-to-use application shall be automatically subject to the security interest granted herein).

SECTION 3. Security for Obligations. The grant of a security interest in the Trademarks by the Grantor under this Trademark Security Agreement is made to secure the payment or performance, as the case may be, in full of the Secured Obligations.

SECTION 4. Recordation. The Grantor authorizes and requests that the Commissioner for Trademarks record this Trademark Security Agreement.

SECTION 5. Execution in Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed signature page to this Trademark Security Agreement by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Trademark Security Agreement.

SECTION 6. Security Agreement. This Trademark Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. The Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Administrative Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event that any provision of this Trademark Security Agreement

is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 7. Governing Law. THIS TRADEMARK SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK WITHOUT GIVING EFFECT TO THE CONFLICTS OF LAWS PRINCIPLES THEREOF (OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST), BUT INCLUDING SECTION 5-1401 OF THE NEW YORK GENERAL OBLIGATIONS LAW.


SECTION 8. Existing Trademark Security Agreement. The parties hereto hereby confirm, acknowledge and agree that nothing contained herein shall impair or adversely affect the continuation without interruption of the Administrative Agent's (as successor in such capacity by appointment and assignment to General Electric Capital Corporation) security interests in the "Trademarks" (as defined in the Existing Trademark Security Agreement). The Grantor, as successor by merger to Strathmore Partners LP hereby ratifies, confirms and affirms the grant of a continuing security interest made pursuant to the Existing Trademark Security Agreement in all respects. Nothing contained herein shall be construed as a novation of the obligations outstanding under the Existing Trademark Security Agreement, which shall remain in full force and effect. Nothing express or implied in this Trademark Security Agreement shall be construed as a release or discharge of any security interest in the "Trademarks" (as defined in the Trademark Existing Security Agreement) granted by any "Grantor" (as defined in the Trademark Existing Security Agreement) to the Administrative Agent (as successor in such capacity by appointment and assignment to General Electric Capital Corporation) under the Existing Trademark Security Agreement, including, without limitation, the Borrower (as successor by merger to Strathmore Partners LP).


