RELEASE OF SECURITY INTEREST IN TRADEMARKS

February 1, 2017

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is conveyed as of February 1, 2017 by JPMORGAN CHASE BANK, N.A., as collateral agent under the Credit Agreement referred to below (in such capacity, the "Agent"), to the Grantors (as such term is defined below). Capitalized terms used herein but not defined herein shall have the meanings ascribed to them in the Credit Agreement or the Trademark Security Agreement, as applicable, referred to below.

WHEREAS, pursuant to (i) that certain Credit Agreement, dated as of January 28, 2015 (as amended, the "Credit Agreement"), by and among **OPTIV GUARANTOR LLC** (formerly known as AF GUARANTOR LLC), a Delaware limited liability company ("Holdings"), **OPTIV BORROWER LLC** (formerly known as AF BORROWER LLC), a Delaware limited liability company (the "Lead Borrower"), the other Borrowers party thereto (such entities, together with the Lead Borrower, each a "Borrower" and collectively, the "Borrowers"), the other Guarantors party thereto from time to time, each lender from time to time party thereto (each, a "Lender" and collectively, the "Lenders"), and the Agent and (ii) that certain Security Agreement, dated as of January 28, 2015 (as amended, , the "Security Agreement"), by and among the Grantors (as such term is defined in the Security Agreement), and the Agent, **OPTIV SECURITY INC.** (formerly known as FISHNET SECURITY, INC. and successor by merger to ACCUVANT, INC.), a Delaware corporation ("Optiv Security") and **OPTIV FEDERAL INC.** (formerly known as ACCUVANT FEDERAL SOLUTIONS INC.), a Maryland corporation ("Optiv Federal") are parties to that certain Trademark Security Agreement (the "Trademark Security Agreement"), dated as of January 28, 2015, with the Agent, which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 28, 2015 at Reel 5448, Frame 0723; and

WHEREAS, pursuant to the Trademark Security Agreement, Optiv Security and Optiv Federal (each a "Grantor" and collectively, the "Grantors") granted a security interest to the Agent in all right, title or interest in or to the collateral described in Section 2 of the Trademark Security Agreement (the "Trademark Collateral"), including the trademarks identified on Schedule A attached hereto (the "Security Interest").


NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, without representation or warranty of any kind, hereby releases the Security Interest granted under the Trademark Security Agreement, and any right, title or interest of the Agent in such Trademark Collateral pursuant to the Trademark Security Agreement shall hereby cease. If and to the extent the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns all of such right, title or interest of Agent to the applicable Grantor.

The Agent acknowledges that this Release may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any conflict of law principles thereof.


