**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of February 3, 2017 (the "Effective Date"), is made by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., in its capacity as the Collateral Agent (the "Agent"), in favor of the grantor parties identified on the signature page hereto (the "Grantor").

WHEREAS, pursuant to that certain Security Agreement, dated as of June 12, 2013, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Grantor granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks, dated as of June 12, 2013 (as may be amended, supplemented, restated, or otherwise modified from time to time) and other similar grants of security interest from time to time (each, a "Trademark Security Agreement", and collectively, the "Trademark Security Agreements"), for recording with the United States Patent and Trademark Office;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the relevant Trademark Security Agreement, as applicable.
2. Release. The Agent, without recourse representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the registered Trademarks and Trademarks with respect to which applications for registration are pending listed on Schedule I attached hereto (the "Trademark Collateral"). If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral the Agent, without recourse representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Termination. The Agent, without recourse representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.
4. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
