RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of February 2, 2017 (“Effective Date”) from Barclays Bank PLC, a limited liability company, located at 1301 Avenue of the Americas, New York, NY 10019, as Administrative Agent (the “Agent”) to Eastman Kodak Company, a New Jersey corporation, Far East Development Ltd., a Delaware corporation, FPC Inc., a California corporation, Kodak (Near East), Inc., a New York corporation, Kodak Americas, Ltd., a New York corporation, Kodak Realty, Inc., a New York corporation, Laser-Pacific Media Corporation, a Delaware corporation, Qualex Inc., a Delaware corporation, Kodak Philippines, Ltd., a New York corporation, and NPEC Inc., a California corporation (collectively “Grantors”), all such Grantors located at 343 State Street, Rochester, New York 14650.

WHEREAS, the Grantors and the Agent have entered into a Senior Secured Second Lien Term Credit Agreement dated as of September 3, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) and a Guarantee and Collateral Agreement dated September 3, 2013, in favor of the Agent (as amended and restated or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, the Grantors and the Agent entered into several Intellectual Property Security Agreements, as described in more detail in Schedule A hereto (the “Intellectual Property Security Agreements” -all capitalized terms used, but not defined herein have the definition assigned to them in the Intellectual Property Security Agreements);

WHEREAS, pursuant to the terms and conditions of the Intellectual Property Security Agreements, the Grantors granted to the Agent a security interest in all of such Grantors’ right, title and interest in or to the Trademarks (including, without limitation, those items set forth on Schedule B attached hereto) (collectively, the “Released Collateral”); and

WHEREAS, the Intellectual Property Security Agreements were recorded at the United States Patent and Trademark Office as described on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates, cancels and releases any and all security interests it has against the Released Collateral, (ii) terminates the Intellectual Property Security Agreements and (iii) hereby transfers and assigns to the applicable Grantor any and all right, title and interest that Agent may have obtained in, to, or under the Released Collateral.

The Agent shall take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such reasonable cooperation and assistance, requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

The Agent hereby authorizes and requests that the United States Patent and Trademark Office record this Release.
