RECITALS

The Assignor has agreed to assign to the Assignee all of its rights, title and interest in the Trade Marks and the Assignee agrees to accept the assignment, on the terms of this Deed.

THE PARTIES AGREE AS FOLLOWS:

1. DEFINITIONS

Deed means this deed of assignment of intellectual property rights.

Effective Date means 14 December 2016

Trade Marks means the trade mark applications set out in Schedule 1 and the trade marks the subject of such applications.

2. ASSIGNMENT

(a) The Assignor assigns to the Assignee all of its right, title and interest in and to the Trade Marks free and clear of all encumbrances and third party rights.

(b) The assignment in clause 2(a):

(i) is with effect from the Effective Date; and

(ii) includes the right to take action and sue for remedies against third parties for infringement, or other claims in relation to the Trade Marks (whether or not the infringement or claim occurred or arose before the Effective Date).

3. FURTHER ASSURANCES

(a) The Assignee agrees to promptly record the assignment of the Trade Marks on the relevant trade mark registers.

(b) The Assignor must execute any documents and do any other things that the Assignee reasonably requests to confirm or perfect any assignment under clause 2(a), or otherwise give effect to the terms of this deed.

4. GENERAL

- (a) This deed is governed by the law in force in Western Australia, Australia.
- (b) Each party irrevocably submits to the non-exclusive jurisdiction of courts exercising jurisdiction in Western Australia, Australia.
- (c) If any provision of this deed is invalid under the law of any jurisdiction the provision is enforceable in that jurisdiction to the extent that it is not invalid, whether it is in severable terms or not.
- (d) In this deed:
 - (i) a promise or assignment made or given by two or more people is done jointly and severally; and
 - (ii) a reference to a party to a document includes that party's successors and assignees.

- (f) This deed includes any schedule.
