RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST, dated as of February 8, 2017 (this "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION (successor by merger to Wilmington Trust FSB), in its capacity as Collateral Agent (the "Releasor"), in favor of HEXION INC. (formerly known as Hexion Specialty Chemicals Inc. and as Momentive Specialty Chemicals, Inc.) (in such capacity, "Hexion"), Hexion Investments Inc. (formerly known as Momentive Specialty Chemicals Investments, Inc. and as Borden Chemical Investments, Inc. ("Hexion Investments"), HSC Capital Corporation ("HSC"), Lawter International Inc. ("Lawter"), Hexion International Inc. (formerly known as Borden Chemical International Inc. and as Momentive International Inc.) ("Hexion International"), Oilfield Technology Group, Inc. ("Oilfield"), Hexion CI Holding Company (China) LLC (formerly known as Momentive CI Holding Company (China) LLC) ("Hexion China"), and Hexion Nova Scotia Finance, ULC ("Hexion NS"), as applicable. Each of Hexion Investments, HSC, Lawter, Hexion International, Oilfield, Hexion China, Hexion NS and Hexion (in its capacity as successor by merger to Hexion U.S. Finance Corp) are referred to herein as a "Hexion Subsidiary" and, collectively, as the "Hexion Subsidiaries."

WHEREAS, reference is made to (i) that certain Indenture, dated as of January 29, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Indenture"), among Hexion, Hexion Finance Escrow LLC, Hexion Escrow Corporation, the subsidiaries of Hexion party thereto and the Releasor (as assumed by Hexion U.S. Finance Corp. and Hexion Nova Scotia Finance ULC pursuant to that certain Supplemental Indenture dated as of January 29, 2010) and (ii) that certain Collateral Agreement, dated as of January 29, 2010 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among Hexion, each subsidiary of Hexion party thereto and the Releasor as Collateral Agent. Capitalized terms used herein but not defined herein shall have the meanings ascribed to them in the Indenture;

WHEREAS, pursuant to and as set forth in the following documents recorded with the United States Patent and Trademark Office ("USPTO"):

(iii) on September 29, 2010 in Reel No. 4286, Frame No. 0571, made by Hexion, BCF, Hexion Investments, HSC, Lawter, Hexion International, Oilfield and Hexion China;

(iv) on March 9, 2011 in Reel No. 4493, Frame No. 0583, made by Hexion, BCF, Hexion Investments, HSC, Lawter, Hexion International, Oilfield and Hexion China;

(v) on July 5, 2011 in Reel No. 4575, Frame No. 0730, made by Hexion, BCF, Hexion Investments, HSC, Lawter, Hexion International, Oilfield, Hexion China and Hexion NS;

(vi) on July 5, 2011 in Reel No. 4575, Frame No. 0749, made by Hexion, BCF, Hexion Investments, HSC, Lawter, Hexion International, Oilfield, Hexion China and Hexion NS;

(vii) on December 12, 2011 in Reel No. 4677, Frame No. 0010, made by Hexion, BCF, Hexion Investments, HSC, Lawter, Hexion International, Oilfield, Hexion China and Hexion NS;

(viii) on December 12, 2011 in Reel No. 4677, Frame No. 0019, made by Hexion, BCF, Hexion Investments, HSC, Lawter, Hexion International, Oilfield, Hexion China and Hexion NS;

(ix) on August 17, 2012 in Reel No. 4844, Frame No. 0733, made by Hexion, BCF, Hexion Investments, HSC, Lawter, Hexion International, Oilfield, Hexion China and Hexion NS;

(x) on October 11, 2013 in Reel No. 5129, Frame No. 0513, made by Hexion;

(xi) on April 25, 2014 in Reel No. 5268, Frame No. 0458, made by Hexion;

(xii) on July 24, 2015 in Reel No. 5584, Frame No. 0292, made by Hexion;

(xiii) on August 2, 2016 in Reel No. 5845, Frame No. 0296, made by Hexion; and

(xiv) on October 13, 2016 in Reel No. 5899, Frame No. 0855, made by Hexion (each of (i) through (xiv), a “Trademark Security Agreement” and collectively with the Collateral Agreement, the “Security Agreements”), Hexion and, as applicable, each Hexion Subsidiaries party thereto granted to the Releasor a security interest in and continuing lien on (referred to in this Release as the “Security Interest”) all of its respective right, title and interest in, to or under the Trademark Collateral (as defined therein), including the United States trademark registrations and applications listed on Schedule I hereto and all related goodwill therein; and

WHEREAS, pursuant to the terms of the Indenture and Collateral Agreement, the Releasor has agreed to terminate and release its Security Interest with respect to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Releasor hereby (i) unconditionally, irrevocably and absolutely terminates, extinguishes, cancels, releases and forever discharges its Security Interest and all of its right, title and interest in or to the Trademark Collateral pledged and granted pursuant to the Security Agreements and (ii) terminates the Security Agreements and reassigns to Hexion (or, as applicable, the relevant Hexion Subsidiary) any and all

right, title and interest that the Releasor may have in or to any of the Trademark Collateral.

2. Authorization to Record. The Releasor authorizes and requests that the USPTO and any applicable government officer record this Release with the USPTO.

3. Further Assurances. The Releasor agrees to cooperate with Hexion and, solely at the expense of Hexion, to provide Hexion with such information and additional authorization and to execute and deliver to Hexion such additional instruments and to take such action, in each case, as Hexion may reasonably request or as may be desirable to effect and record with the USPTO the release of the Releasor's Security Interest in or to the Trademark Collateral.

4. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York.
