WHEREAS Current Owner is the owner of several trademarks in the United States of America.

WHEREAS Current Owner shall be merged into the Future Owner by way of an upstream merger. The merger will be governed by German law and will become effective with the record of the merger in the commercial register of Future Owner. According to the principle of universal succession stipulated under German law, all assets and liabilities including the trademarks (including applications for registrations) owned by Current Owner will be automatically transferred from Current Owner to Future Owner with the effective date of the merger.

WHEREAS there is a risk that the principle of the universal succession of all assets, including IP rights such as trademarks and patents is not known or accepted in all jurisdictions in which Current Owner owns trademarks and, consequently, the transfer of the IP rights (trademarks and patents) may not be effectuated by mere virtue of the merger.

WHEREAS for the purpose of this agreement the **Trademarks** of the Current Owner are deemed to be all existing trademarks of the Current owner in the United States of

3. Miscellaneous

If any provision of this agreement shall be adjudged by any court to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that this agreement otherwise remains in full force and effect.

This agreement is subject to German law. The courts of Hamburg, Germany, have exclusive jurisdiction.

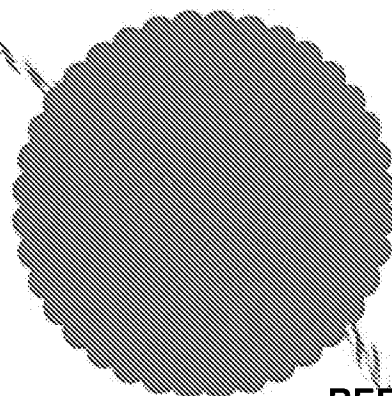
