RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 14th day of February, 2017, by PNC BANK, NATIONAL ASSOCIATION, as agent for the lenders (in such capacity, the "Agent").

WHEREAS, reference is made to the (i) Intellectual Property Security Agreement dated as of November 5, 2012 and recorded with the United States Trademark and Trademark Office on November 27, 2012, at **Reel 4907 Frame 0449** (recorded as PNC Bank, National Banking Association as Assignee) (as may be amended, restated, amended and restated, supplemented and/or modified to date, the "IP Security Agreement"), by SIDEWINDER DRILLING INC., a Delaware corporation ("Holdings"), CROWN DRILLING OF PENNSYLVANIA, LLC, a Pennsylvania limited liability company ("Crown") and UNION DRILLING, INC., a Delaware corporation ("Union"; and together with Holdings and Crown, individually, each a "Grantor" and collectively, the "Grantors"), in favor of Agent. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Intellectual Property Security Agreements.

WHEREAS, under the IP Security Agreement, Grantors granted to Agent, for the benefit of itself and the Lenders, a continuing security interest in all of the right, title and interest of Grantors in and to the Collateral (as defined in the Intellectual Property Security Agreement) identified therein, including, but not limited to, the Trademarks set forth on the Schedule A attached hereto.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby (i) terminates the Intellectual Property Security Agreement, (ii) releases any and all liens on, and its security interest in and to the Collateral arising under the Intellectual Property Security Agreement, including, but not limited to, the Trademarks set forth on the schedule attached hereto, and (iii) authorizes the recordation of this Release by Grantors or its designee with the United States Patent and Trademark Office.
