## ASSIGNMENT OF PARTNERSHIP INTERESTS

THIS ASSIGNMENT OF PARTNERSHIP INTERESTS (this "Assignment") is made and entered into for all purposes effective as of June 5, 2015 (the "Effective Date"), by and among Blue Sage Capital, L.P., a Delaware limited partnership ("Blue Sage"), Mr. G's Holdings GP, LLC, a Texas limited liability company ("GP Seller" and together with Blue Sage, each an "Assignor" and collectively, the "Assignors"), and Sovrano, LLC, a Delaware limited liability company ("LP Buyer"), and Sovrano GP, LLC, a Delaware limited liability company ("GP Buyer" and together with LP Buyer, each an "Assignee" and collectively, the "Assignees").

### WITNESSETH

WHEREAS, Assignors hold partnership interests in one or more of the following entities, as set forth on Exhibit A attached hereto: MGI Holdings, LP, a Texas limited partnership, and Mr. Gatti's, LP, a Texas limited partnership (collectively, the "Companies");

WHEREAS, Assignors and Assignees have entered into that certain Partnership Interest Purchase Agreement dated as of May 6, 2015 (the "Purchase Agreement"); and

WHEREAS, Assignors desire to transfer, and Assignees desire to acquire, all of Assignors' partnership interests that Assignors have in the Companies, as set forth on Exhibit A attached hereto (the "Assigned Interest").

NOW, THEREFORE, in consideration of the foregoing premises and other valuable consideration set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignment of Interest. Pursuant to the terms and conditions of the Purchase Agreement, Assignors hereby transfer and assign to Assignees, and each Assignee hereby acquires from Assignors, the Assigned Interest specifically set forth on Exhibit A, including but not limited to, that portion of the right, title and interest of each Assignor in and to the properties (real and personal), capital, cash flow, distributions and profits and losses of the Companies that are allocable to the Assigned Interest.
2. Effective Date. The assignment herein is effective as of the Effective Date, and from and after that date, that portion of the net profits or net losses of the Companies allocable to the Assigned Interest shall be credited or charged, as the case may be, to the relevant Assignee and not to any Assignor.
3. Further Assurances. Each Assignor and each Assignee further agree that each will do or cause to be done such further acts and shall execute, acknowledge, and deliver such further instruments as may be reasonably required by any of them to fully effectuate the assignment made herein.
4. Successors and Assigns. This Assignment shall be binding upon, and shall inure to the benefit of, the parties hereto and their respective heirs, legal representatives, successors and assigns.

5. Modification and Waiver. No supplement, modification, waiver or termination of this Assignment or any provisions hereof shall be binding unless executed in writing by the parties to be bound thereby. No waiver of any of the provisions of this Assignment shall constitute a waiver of any other provision (whether or not similar), nor shall such waiver constitute a continuing waiver unless otherwise expressly provided.

6. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Texas, without regard for its conflict of law principles.

7. Counterparts. This Assignment may be executed in any number of counterparts each of which shall be an original and all of which shall together constitute one and the same Assignment.




